## Current Updates 4/08/20

#### **GOVERNOR OF WYOMING**

The Governor issued a directive regarding out-of-state travelers and returning residents.

- Visitors and returning citizens who enter Wyoming must self-quarantine for 14 days upon arrival in Wyoming.
- Any individual visiting the state for a period shorter than 14 days must quarantine for the entirety of the visit. Any individual who arrived in the state prior to this directive must self-quarantine for the remainder of a 14-day period, beginning on the date of their arrival.

#### **COVID-19 Status**

• Kaycee has 0 confirmed cases to date.

## JOHNSON COUNTY HEALTHCARE CENTER

#### **COVID-19 Status**

- Wyoming has 230 lab-confirmed cases and 73 probable cases. Probable cases are identified family members of a confirmed case who exhibit symptoms but have not been tested.
- This figure includes 94 documented recoveries. Johnson County has 8 confirmed cases; 2 probable cases; 7 have recovered. 1 still self-isolated.
