## "BUELL ADDITION" TO THE CITY OF BUFFALO, WYOMING

A tract of land located in Lot 4 of Section 2, and Lot 1 of Section 3, T50N, R82W, of the  $6^{th}$  P.M., Johnson County, Wyoming, said tract being more particularly described as follows:

Commencing at an existing stone marking the northwest corner of said Section 2, said stone being the true point of beginning,

thence N89'35'12'E along said North line of said Lot 4 of said Section 2 and along the South line of the Eychaner Addition to the City of Buffalo, a distance of 499.45 feet to a point, said point being the northwest corner of the Bergner Addition to the City of Buffalo;

thence S00°52'14'E along the West line of said Bergner Addition a distance of 1356.00 feet to the southwest corner of said Bergner Addition, said point also lying on the northerly line of County Road No. 224 (Cenetery Road);

thence S89°56'20'W along said northerly line of said County Road No. 224, a distance of 740.65 feet to a point, said point lying on the West line of said Lot 1 of said Section 3 and on the East line of the Meadowlark Addition to the City of Buffalo;

thence NO2'31'34'W along said West line of said Lot 1 of said Section 3 and along said East line of said Meadowlark Addition and along the West line of Park Addition to the City of Buffalo, a distance of 1352.32 feet to the northwest corner of said Lot 1 of said Section 3;

thence N89'35'12'E along the North line of said Lot 1 of said Section 3, a distance of 280.20 feet to the true point of beginning.

Said tract containing 23.6 acres, more or less.

The City of Buffalo, Wyoming, has caused the same to be annexed in the manner as shown on this plat by Ordinance 1179, which annexation shall be known as the 'Buell Addition'
