thence S0415'17"E a distance of 1338.58 feet to a point, said point lying on the Southerly Right-of-Way line of South Main Street (Connector to Interstate 25), and said point being the point of beginning of said tract of

thence S02°03'52"E (Record S02°04'55"E) a distance of 1177.53 feet (Record 1177.40 feet) to a point;

thence S43'35'18"E (Record S43'36'22"E) a distance of 240.43 feet to a

thence N89°43'51"E (Record N89°42'47"E) a distance of 721.15 feet to a point, said point lying on the Westerly Right-of-Way line of Interstate 25; thence along said Westerly Right-of-Way line of said Interstate 25, \$20.45'03"E a distance of 954.37 feet to a point;

thence continuing along said Westerly Right—of—Way line of said Interstate 25, S11'49'38"E a distance of 449.42 feet to a point;

thence N89'44'44"W (Record N89'09'36"W) a distance of 1762.11 feet (Record 1762.74 feet) to a point, said point lying on the Easterly Right-of-Way line

of Old Highway 87 (Wyoming 196); thence along said Easterly Right-of-Way line of said Old Highway 87 (Wyoming 196), S13'15'25"E a distance of 19.54 feet to a point, said point lying on the South line of the NE¼SW¼ of said Section 2;

lying on the South line of the NE¼SW¼ of said Section 2; thence along said South line of said NE¼SW¼ of said Section 2, S89°34′35″W a distance of 102.56 feet to a point, said point lying on the centerline of said Old Highway 87 (Wyoming 196); thence along said centerline of said Old Highway 87 (Wyoming 196), N13°15′25″W a distance of 2443.74 feet to the point of beginning of a tangent circular curve to the right having a radius of 1637.02 feet; thence continuing along said centerline of said Old Highway 87 (Wyoming 196) and along said tangent circular curve to the right, through a central angle of 21°32′00″ a distance of 615.24 feet to a point, said point lying on said Southerly Right—of—Way line of said South Main Street (Connector to said Southerly Right-of-Way line of said South Main Street (Connector to Interstate 25), and said point being the point of beginning of a non-tangent circular curve to the left having a radius of 1054.90 feet, the bearing to the radius being N27'56'51"E;

thence along said Southerly Right-of-Way line of said South Main Street (Connector to Interstate 25) and along said non-tangent circular curve to the left, through a central angle of 14 17 28" a distance of 263.12 feet to the point of ending of said non-tangent circular curve to the left; thence continuing along said Southerly Right-of-Way line of said South Main

Street (Connector to Interstate 25), S76'20'37"E a distance of 866.73 feet to the true point of beginning of said tract of land.
