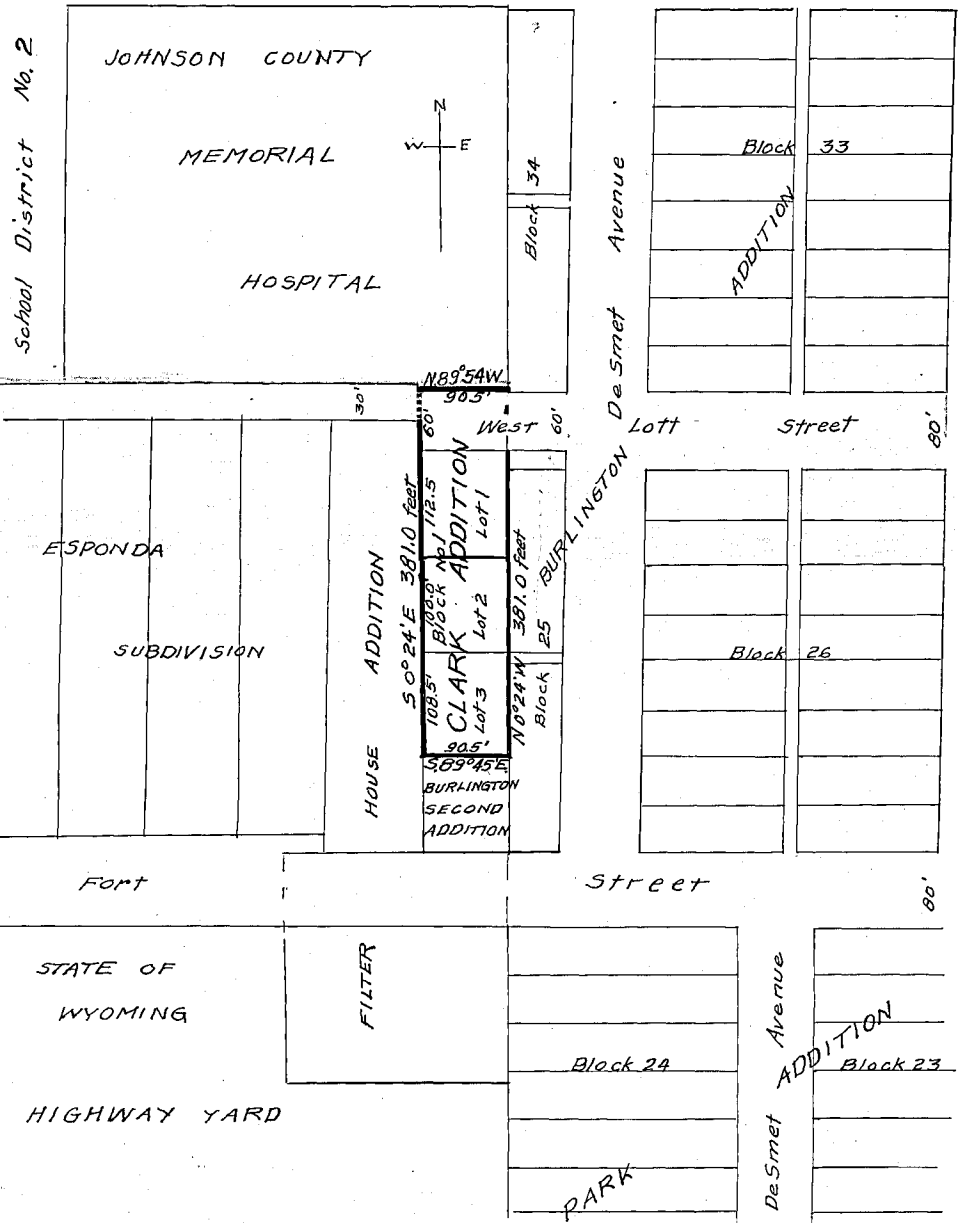


CLARK ADDITION

CERTIFICATE OF DEDICATION

The undersigned hereby certify that the following described tract in Lot No. 6 of Section 34, in Township 51 North, Range 82 West of the Sixth Principal Meridian, in Johnson County, Wyoming, the border lines of which are described as follows, to wit: - Beginning at a point 1600 feet South 0 degrees 24 minutes East from the northeast corner of Lot No. 5 of said Section 34, which point is also on the West line of Block No. 25 of the Burlington Addition of the City of Buffalo, Wyoming and at a point which is equal distances from the southwest and northwest corners of said Block No. 25, Running thence North 0 degrees 24 minutes West 280 feet to the Southwest corner of Block No. 34 of said Burlington Addition; thence North 89 degrees and 54 minutes West 90.5 feet; thence South 0 degrees 24 minutes East 381 feet; thence South 89° 45' East 90.5 feet to a point on the Eastline of Lot No. 6; thence North 0 degrees and 24 minutes West 101.0 feet to the point of beginning, as it appears on this plat is with the free consent and approval of the undersigned owners of the property hereon set forth, that the name of said subdivision shall be **CLARK ADDITION TO THE CITY OF BUFFALO, JOHNSON COUNTY, WYOMING**, and the streets, avenues, and roads as may be shown on this plat are hereby dedicated to public use.
