

FOLDED HILLS RESTING PLACE

CERTIFICATE OF DEDICATION PERIMETER DESCRIPTION

A tract of land known as the "Folded Hills Resting Place" located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 35, T49N, R82W, of the 6th P.M., Johnson County, Wyoming, being more particularly described as follows:

Commencing at an existing Brass Cap, stamped "PELS 2085", marking the south quarter corner of said Section 35;
 thence N32°14'34"W a distance of 2185.51 feet to the true point of beginning of said tract of land;
 thence N81°43'36"W a distance of 70.00 feet to a point;
 thence N08°16'24"E a distance of 50.00 feet to a point;
 thence S81°43'36"E a distance of 70.00 feet to a point;
 thence S08°16'24"W a distance of 50.00 feet to the true point of beginning of said tract of land;

Said tract of land containing 0.08 acres, more or less.

Folded Hills Resting Place consists of 35 Plots being 4' wide & 8' long with the exception of Plot 32 being 5' wide & 8' long as shown on this Cemetery Plat. Walkways as shown on this Cemetery Plat are hereby dedicated for access to the Plots.

The undersigned Owners and Proprietors of the above described tract of land have caused the same to be surveyed and laid out as the "Folded Hills Resting Place" in the manner as shown on this plat, and do hereby dedicate the above described tract of land for the sole purpose of being used forever more as a burial ground for human remains.

Said plat is proposed and offered with free consent and in accordance with the desires of the undersigned Owners and Proprietors, and the undersigned Owners and Proprietors do hereby release and waive all rights under the Homestead Exemption Laws of the State of Wyoming.

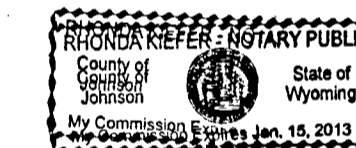

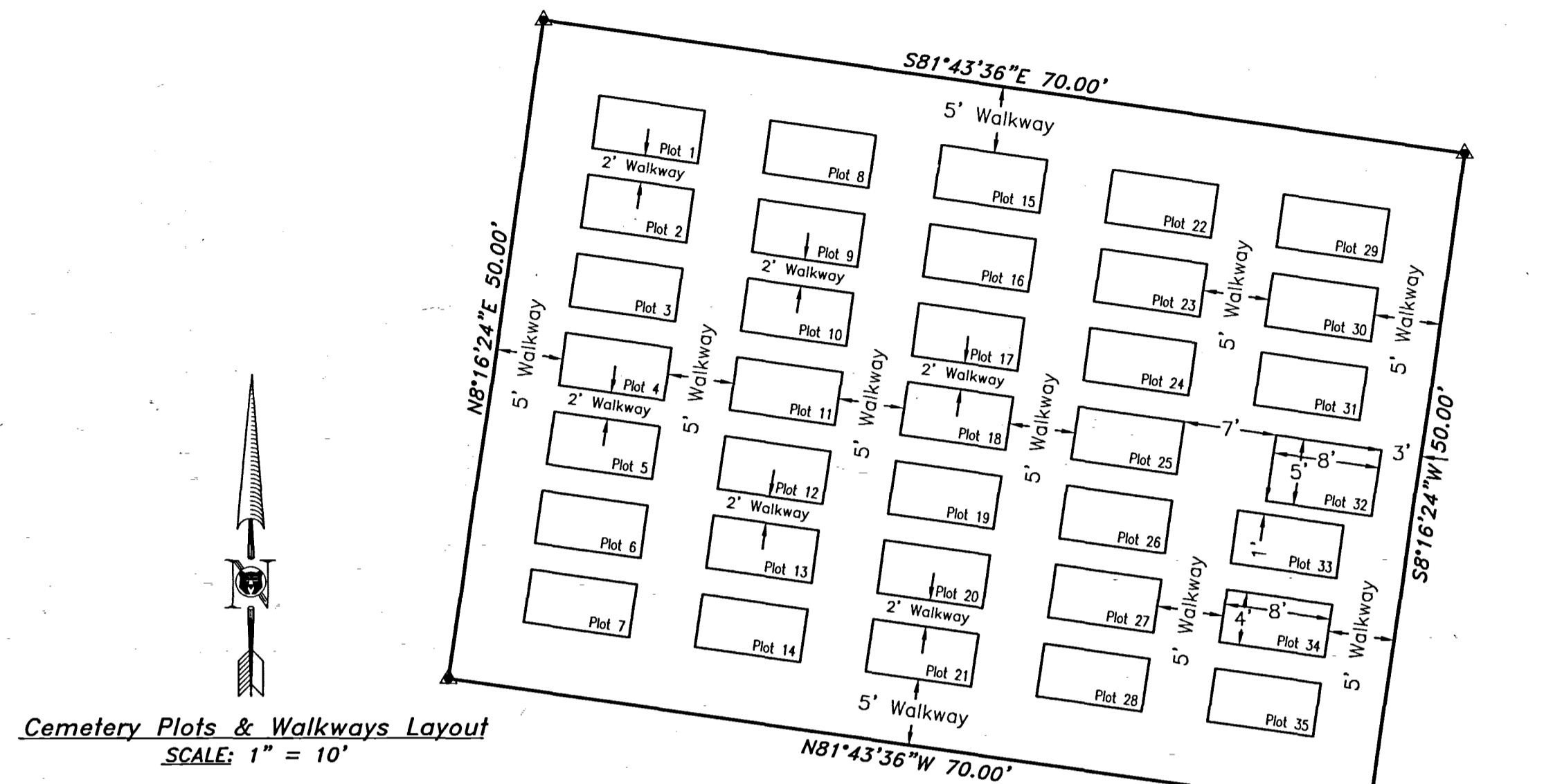

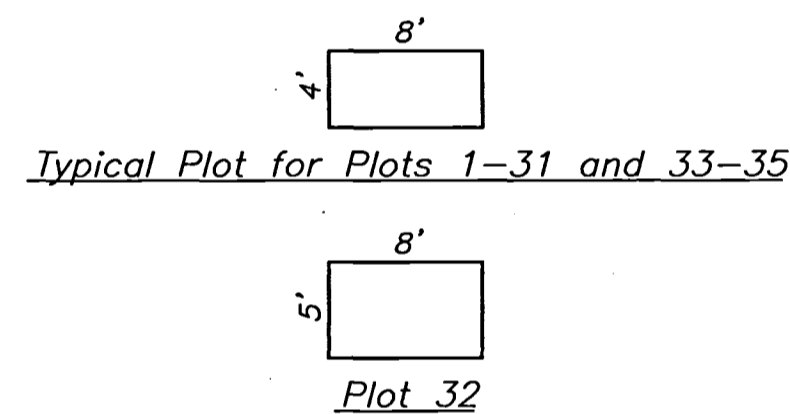

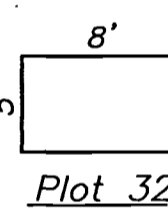

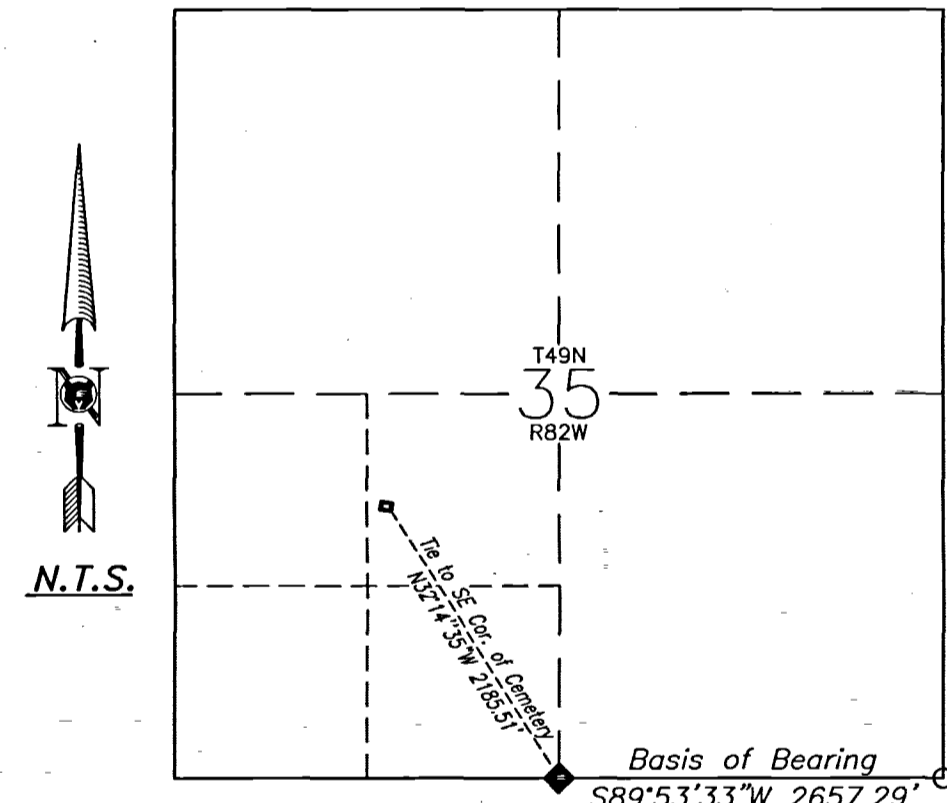

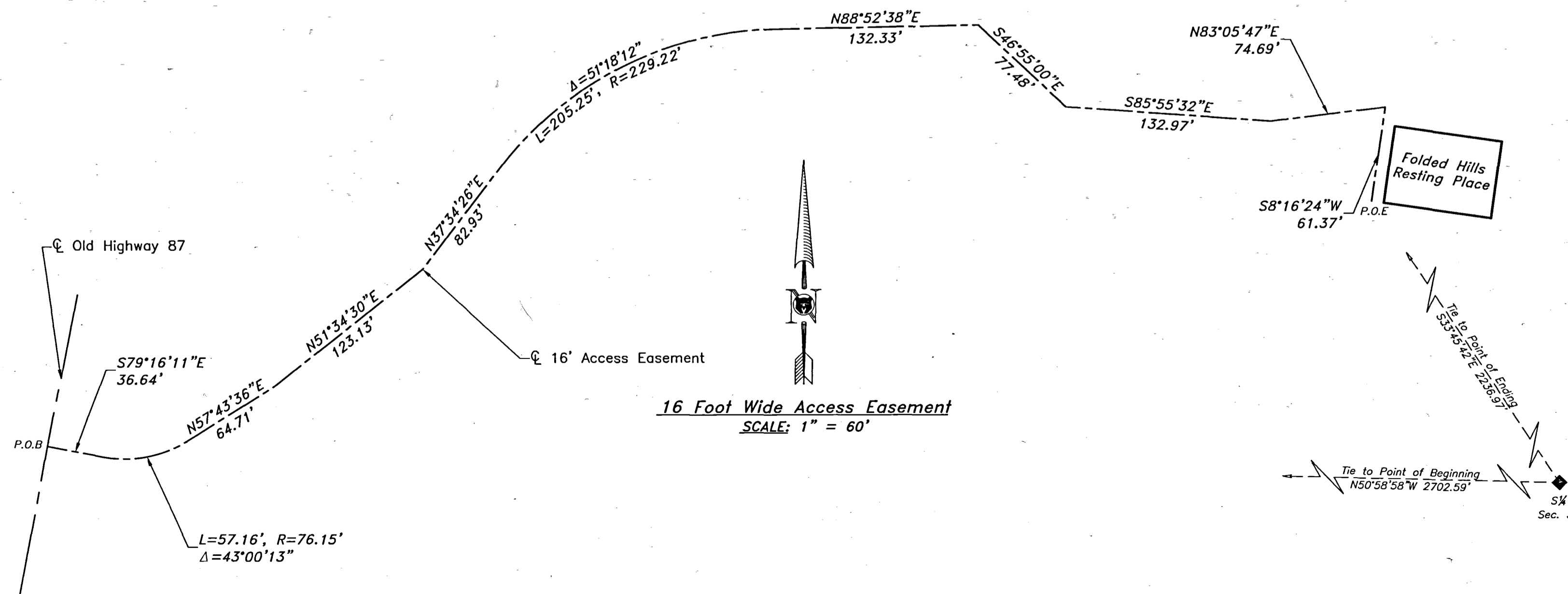
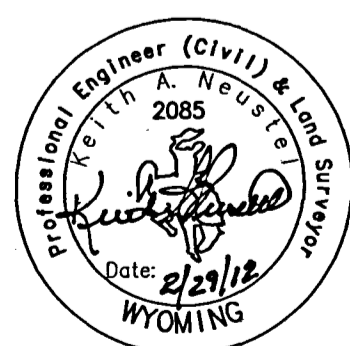
A 16' wide Access Easement is reserved from the centerline of Old Highway 87 to the "Folded Hills Resting Place."
