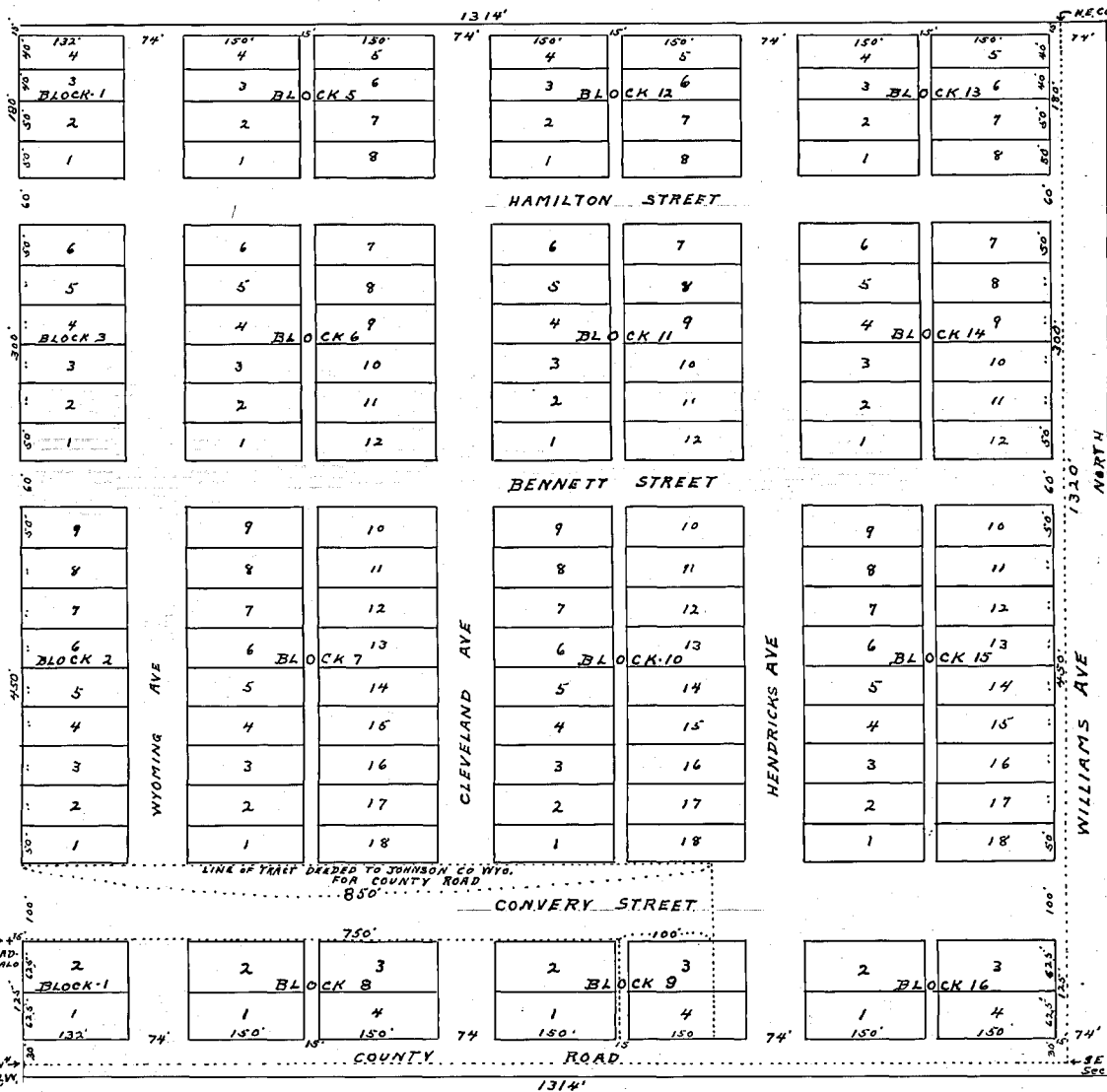

The above, foregoing and annexed Subdivision of the following described tract of land, to-wit:

A strip of land fifty nine (59) feet wide and thirteen hundred and twenty (1320) feet long off the west side of the North West Quarter of the South East Quarter (NW¹/₄ SE¹/₄) of Section Thirty Five (35) Township Fifty one (51) North of Range Eighty two (82) West and more particularly described as follows: Beginning at the south West corner of the said Subdivision Fifty Nine (59) feet; thence northward thirteen hundred and twenty (1320) feet more or less to the north line of said subdivision; thence westward fifty nine (59) feet to the west line of said subdivision; thence southward along the west boundary of said subdivision to the place of beginning; Also all of the North East Quarter of the South West Quarter (NE¹/₄ SW¹/₄) of section thirty five (35) Township Fifty one (51) North of Range Eighty Two (82) West, excepting that portion lying south and west of the North and East line of Road Survey N 279 of Johnson County as the same appears of record, said excepted tract being approximately 257 feet wide and 850 feet long and extending from the south West corner of said Subdivision easterly along the south line thereof
