

KREMERS ADDITION

Town of Kaycee, Wyoming PERIMETER DESCRIPTION

A parcel of land located in the NW¼SE¼ of Section 12, T.43N., R.82W., of the 6th P.M., Johnson County, Wyoming, said parcel being more particularly described as follows:

Commencing at the Center 1/4 corner of said Section 12, being a steel rod with a 21/2 inch aluminum cap; thence S75°21'02"E a distance of 744.75 feet, to the southerly Right-of-Way of WT-Thom Road marked by an aluminum capped rebar stamped PLS 10566, which marks the beginning of a non-tangent circular curve to the left, which is the POINT OF BEGINNING of this description;

Thence along said southerly Right-of-Way of WY-Thom Road, which follows the arc of said nontangent-circular curve to the left, a distance of 275.48 feet, said curve having a radius which bears N23°59'09"E, a distance of 710.55, a central angle of 22°12'50", and a long chord which bears \$77°07'16"E, a distance of 273.76 feet, to an aluminum capped rebar stamped PLS 10566;

thence along said southerly Right-of-Way of WY-Thom Road N88°47'15"E a distance of 56.27 feet to an aluminum capped rebar stamped LS 324;

thence S08°46'55"E a distance of 158.04 feet to an aluminum capped rebar stamped

thence S86°38'14"W a distance of 56.98 feet to an aluminum capped rebar stamped LS

thence S44°03'47"W a distance of 267.79 feet to an aluminum capped rebar stamped

thence S04°42'24"E a distance of 142.96 feet to an aluminum capped rebar stamped

thence S86°01'10"W a distance of 370.08 feet to an aluminum capped rebar stamped

thence N23°35'41"E a distance of 632.86 feet to the Point of Beginning of this description, containing 4.89 acres, more or less, and subject to all easements, right-of-ways, and restrictions of record.

Basis of bearing being \$0.03'31"E a distance of 1318.09 feet between said Center 1/4 corner of Section 12 and an iron pipe marking the C-S $\frac{1}{16}$ corner of said Section 12.

STATEMENT ON EASEMENTS

All easements either recorded or as shown on this plat are hereby dedicated for their stated or intended use.


