

# CERTIFICATE OF DEDICATION

A TRACT OF LAND KNOWN AS THE "MILLER FAMILY CEMETERY" LOCATED IN THE NE1/4NW1/4 OF SECTION 25, T48N, R84W, OF THE 6th P.M., JOHNSON COUNTY, WYOMING, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING GLO BRASS CAP MARKING THE CORNER COMMON TO SECTIONS 23, 24, 25, AND 26, T48N, R84W;  
 THENCE S63°37'42"E A DISTANCE OF 2464.73 FEET TO AN ALUMINUM CAPPED REBAR, STAMPED LS 5367, SAID ALUMINUM CAPPED REBAR BEING THE TRUE POINT OF BEGINNING;  
 THENCE N24°52'20"E A DISTANCE OF 46.40 FEET TO AN ALUMINUM CAPPED REBAR, STAMPED LS 5367;  
 THENCE S65°07'40"E A DISTANCE OF 35.00 FEET TO AN ALUMINUM CAPPED REBAR, STAMPED LS 5367;  
 THENCE S24°52'20"W A DISTANCE OF 46.40 FEET TO AN ALUMINUM CAPPED REBAR, STAMPED LS 5367;  
 THENCE N65°07'40"W A DISTANCE OF 35.00 FEET TO THE TRUE POINT OF BEGINNING.

SAID TRACT OF LAND CONTAINING 0.037 ACRES, MORE OR LESS.

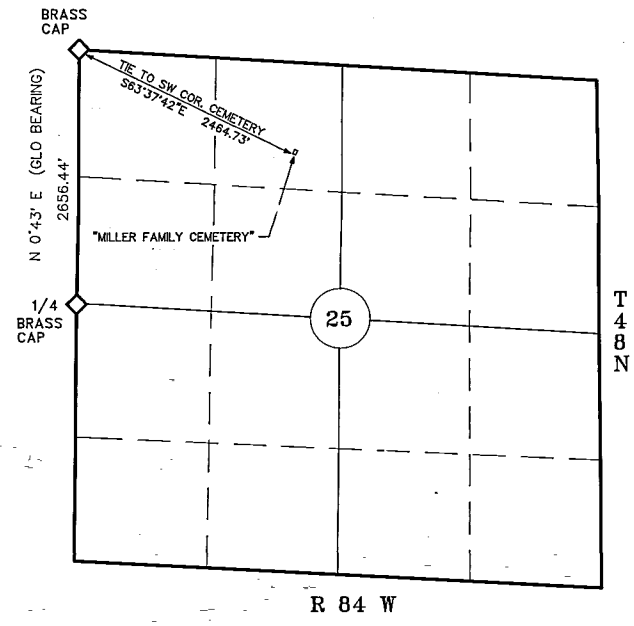

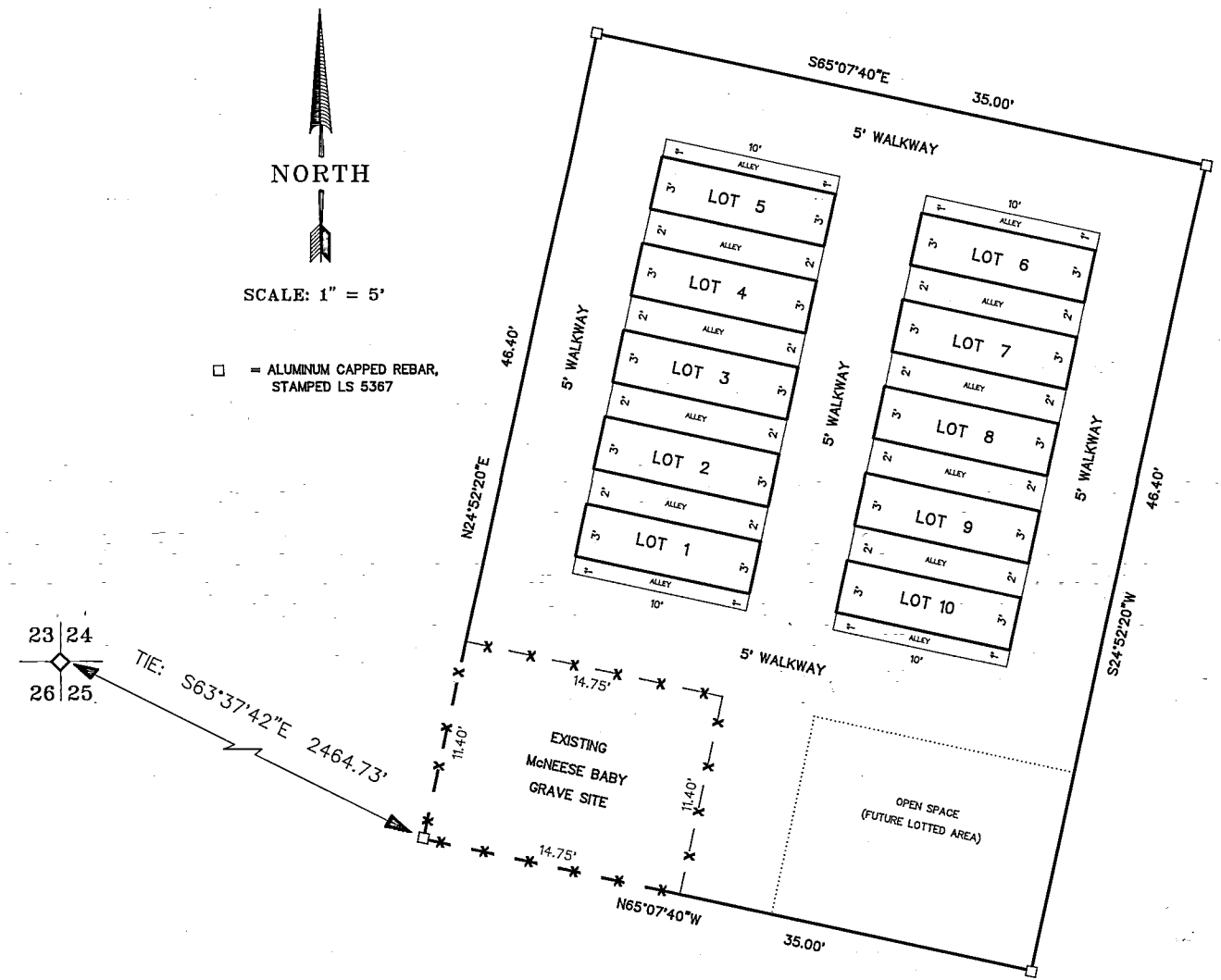
## VICINITY MAP

 JOHNSON COUNTY, WYOMING

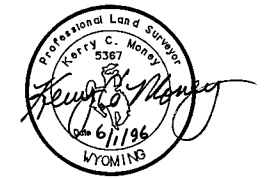
