Mer; thence N 89° 54' W 592.51' along said line to the northwest corner of said SE 1/4 Sec 35; thence S 00° 14' E 733.37' along the east line of the Original City of Buffalo, Wyoming to the northwest corner of the said Sanna Addition thence N 89° 04' E a distance of 592.51' along the north line of Sanna Addition to the point of beginning, the above described tract containing 9.83 acres, and situated in the SE 1/4 Sec. 35 T7S.14R.82W 6th Prin. Mer.
