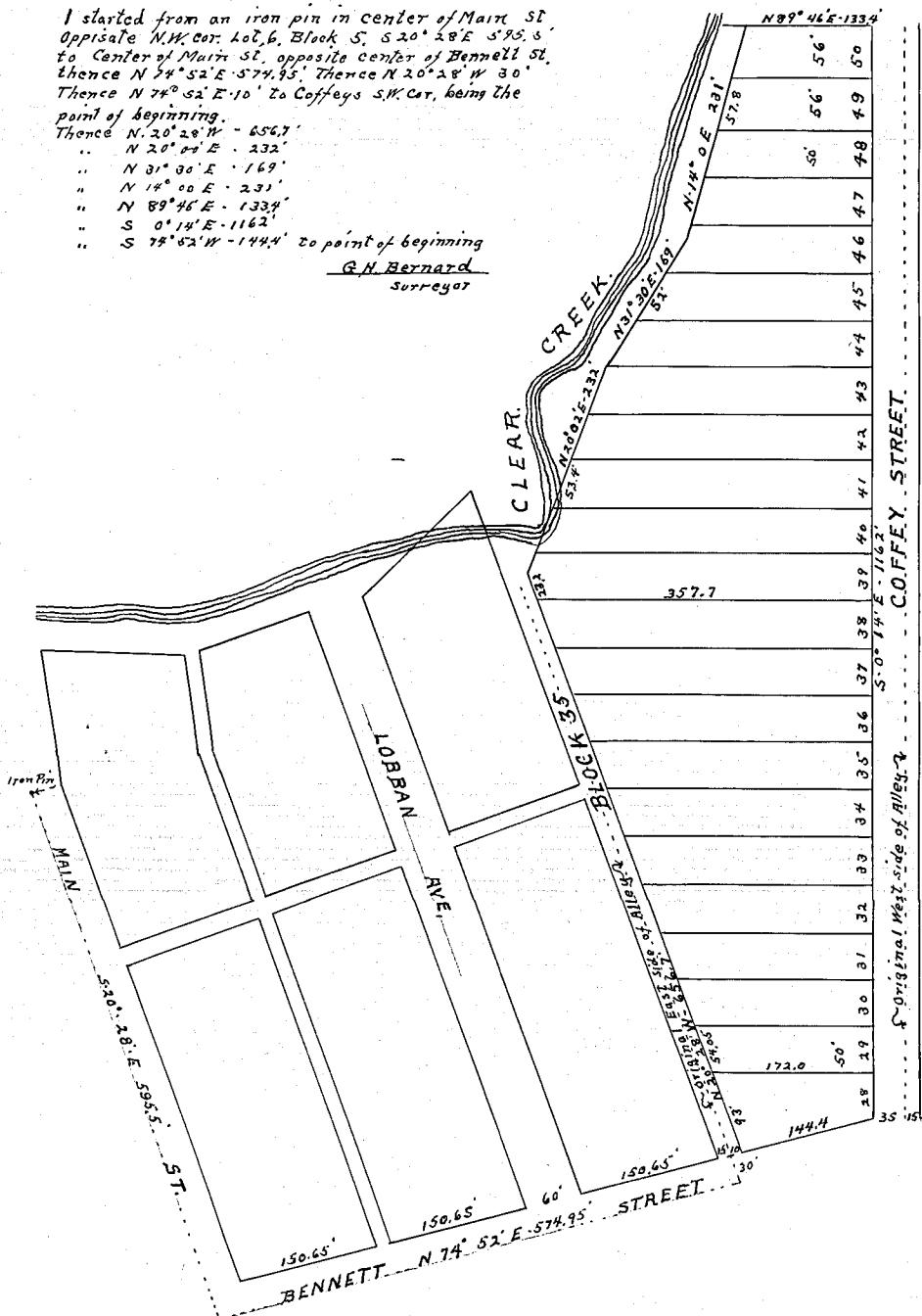


I started from an iron pin in center of Main St

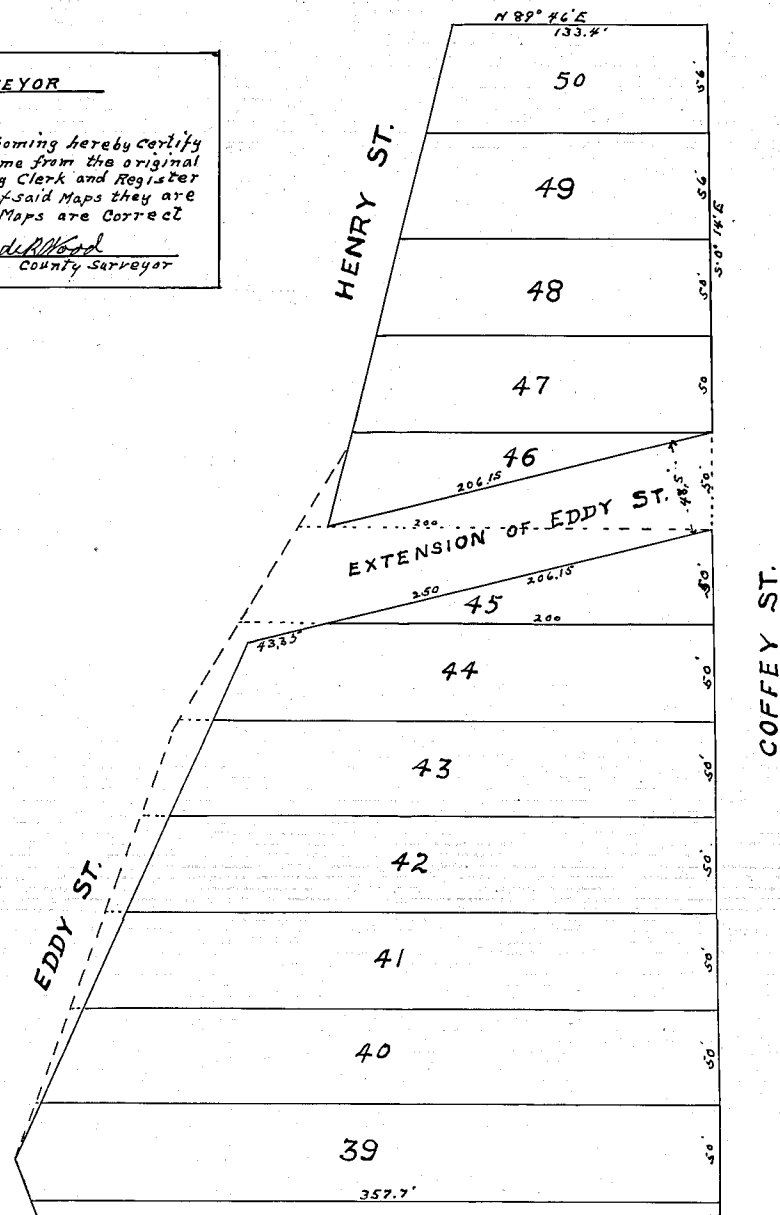
