Beginning at the closing corner to Ft. McKinney Military  
Reservation between Sections twenty six (26) and Thirty  
five (35) of Township, Fifty one (51) North, Range Eighty  
two (82) West of the Sixth Principal Meridian in said  
county and Territory, running thence South Eighty Eight  
degrees and Fifty Four minutes East (S 88° 54' E) Eighteen  
hundred and sixty three (1863) feet to a post; thence  
South fourteen minutes (14') East Thirteen hundred  
and Twenty (1320) feet to a post; thence South Eighty  
Eight degrees and Fifty four minutes West (S 88° 54' W)  
Six Hundred and Sixty feet to a post, thence South  
Fourteen minutes (14') East Two Thousand Six Hundred  
and Six and one tenth (2006.1) feet to a point on the  
line between the land of Juliet, W. Hart and the land  
of N.G. Carwile; thence North Eighty Nine degrees and  
Fifty minutes West (N 89° 50' W) along the line between said  
lands Six Hundred and Forty Four and three tenths (644.3)  
feet to a point on the West side of Main Street; thence

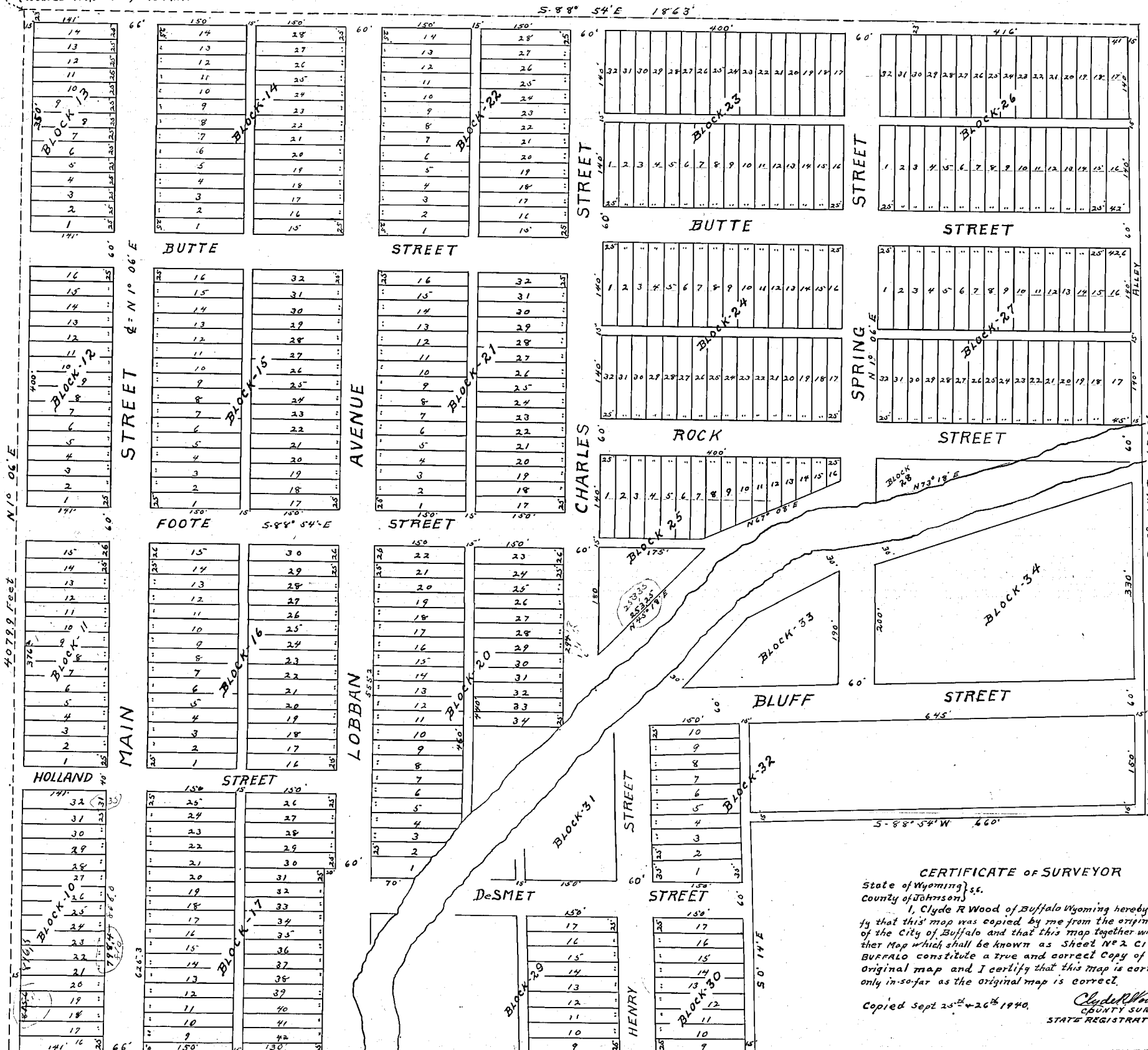

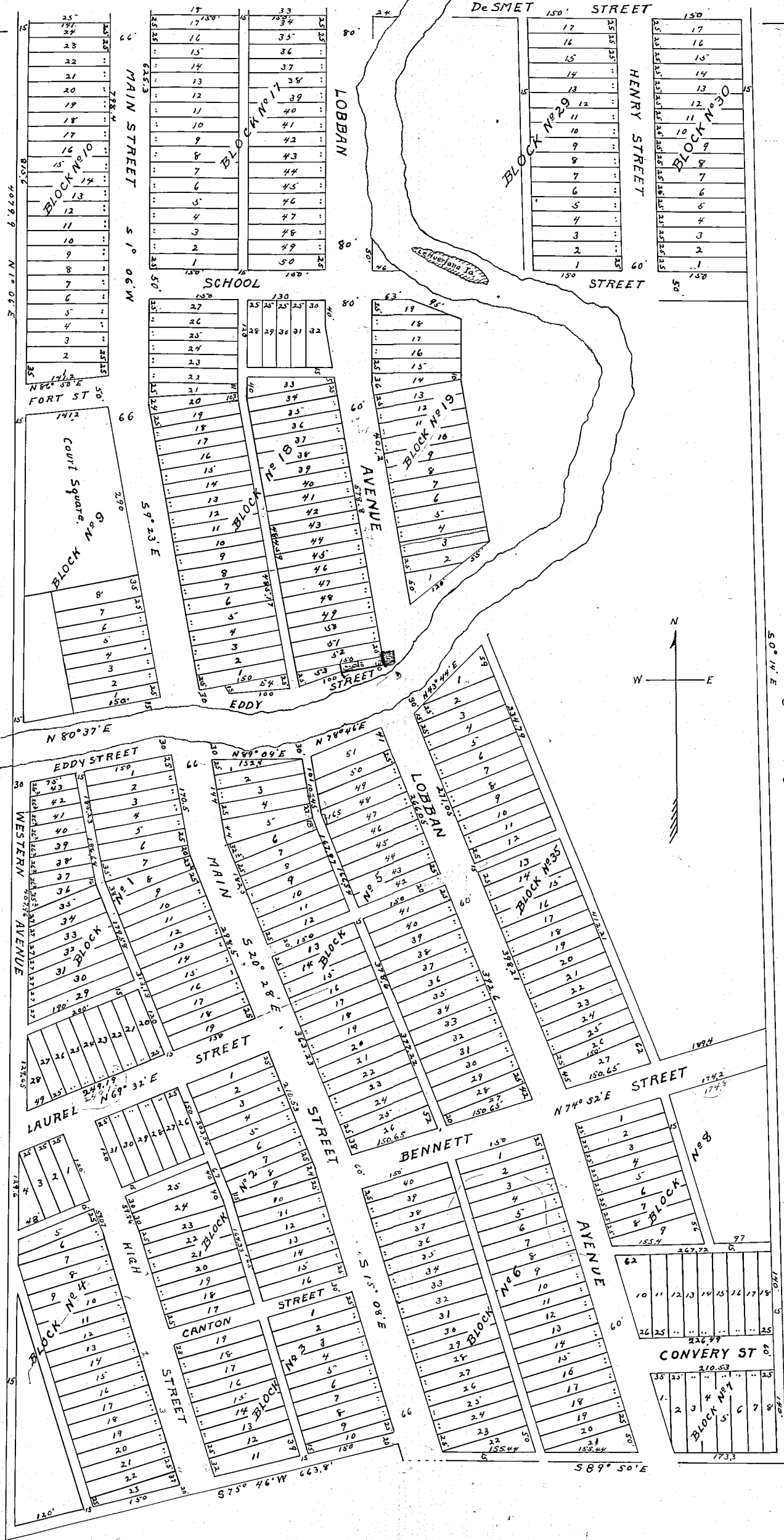
