

(FOR DE-ANNEXATION)

A tract of land in the N¹₂SE¹₄ and SW²₄SE¹₄ of Section 12, T43N, R82W of the 6th P.M., Johnson County, Wyoming described as follows:

Beginning at the Sk corner of said Section 12; thence along the West line of said SE4 Section 12, N 0° 01' 26" E, 1318.05 feet; thence leaving said West line, S 89° 36' 09" E, 224.91 feet; thence N 23° 35' 33" E, 1235.88 feet to the South line of the County Road; thence along said South line through a curve to the left having a radius of 710.55 feet, an arc length of 129.60 feet and chord S 71° 00' 40" E, 129.43 feet; thence leaving said South line, S 1° 13' 00" E, 99.17 feet; thence N 88° 47' 00" E, 150.00 feet; thence S 44° 14' 30" E, 102.59 feet; thence N 88° 47' 00" E, 180.00 feet; thence N 1° 13' 00" W, 150.00 feet to the South line of the County Road; thence along said South line, N 88° 47' 00" E, 250.00 feet to the West line of U.S. Highway 87; thence along said West line, SO° 15' 02" E, 512.78 feet; thence through a curve to the right having a radius of 1859.86 feet, an arch length of 172.57 feet and chord, S 2° 24' 28" W, 172.51 feet; thence leaving said West line, S 89° 45' 38" W, 174.00 feet; thence S 0° 15' 12" E, 120.00 feet; ; thence S 8° 11' 04" W, 120.00 feet; thence S 76° 22' 01" E, 150.00 feet to the West line of U.S. Highway 87; thence along said West line through a curve to the right having a radius of 1859.86 feet, an arch length of 333.51 feet and chord, S 18° 47' 45" W, 333.06 feet; thence S 23° 55' 58" W, 57.42 feet; thence leaving said West line, N 74° 57' 47" W, 396.89 feet; thence S 17° 21' 52" W, 362.08 feet; thence S 55° 02' 12" E, 357.30 feet to the West line of U.S. Highway 87; thence N 62° 51' 04" E, 159.69 feet to the East line of U.S. Highway 87; thence along said East line, S 23° 55' 58" W, 763.60 feet to the South line of said SE' Section 12; thence along said South line, N 89° 46' 52" W, 946.24 feet to the point of beginning.
