

REIMANN ADDITION

The above and foregoing subdivision of the following tract of land, to wit:

This is a subdivision of a tract of land in SW 1/4 SE 1/4 of Section 26, T. 51 N., R.82 W., 6th P.M. Wyoming, more particularly described as fowllows:

Beginning at a point on the south line of Section 26, T.51 N., R.82 W. 6th P.M. Wyoming, bearing N.89-35'17"E. a distance of 389.20 feet from the south quarter corner of said Section 26; thence N.89-35'17 'E. a distance of 202.14 feet to a point intersecting the west right-of-way line of Interstate 25 as extended across the south line of said Section 26; thence N.9-23'05"W. along the west right-of-way line of Interstate 25 a distance of 202.48 feet; thence N.89-35'17"E. a distance of 170.56 feet; thence S.0-24'43"E. a distance of 200.00 feet to the point of beginning, containing 0.856 acres, all lying in the SW 1/4 SE 1/4 of said Section 26.

The undersigned proprietors of the above described tract of land have caused the same to be subdivided in the manner shown on the Plat which subdivision shall be known as "REIMANN ADDITION"

Said Plat is proposed and offered with free consent and in accordance with the desires of the undersigned owners and proprietors, and the undersigned owners and proprietors do hereby release and wave all right, under and by virtue of the homestead exemption laws of the State of Wyoming.

EASEMENTS

An easement is hereby dedicated for public use, the location of such easement is shown in dotted lines on this plat, and said easements shall be employed in perpetuity as a convenant running with the land for the puposes of installing, repairing, re-enstalling, replacing, and maintaining sewerlines, waterline, and other types of public utilities now or hereafter being generally utilized by the public.

STREETS

Streets shown on this plat and not heretofore dedicated to public use are hereby so dedicated.
