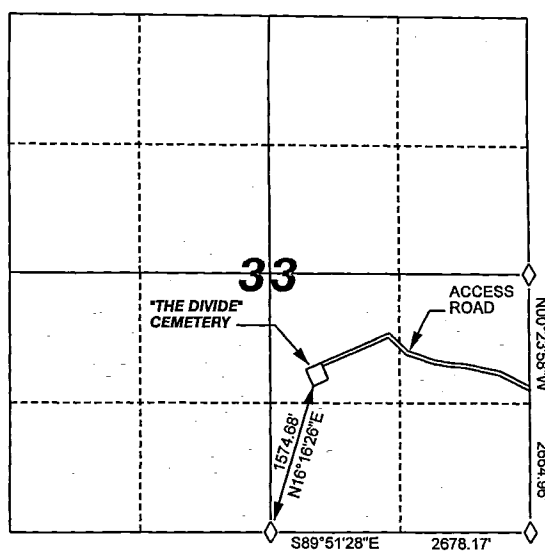
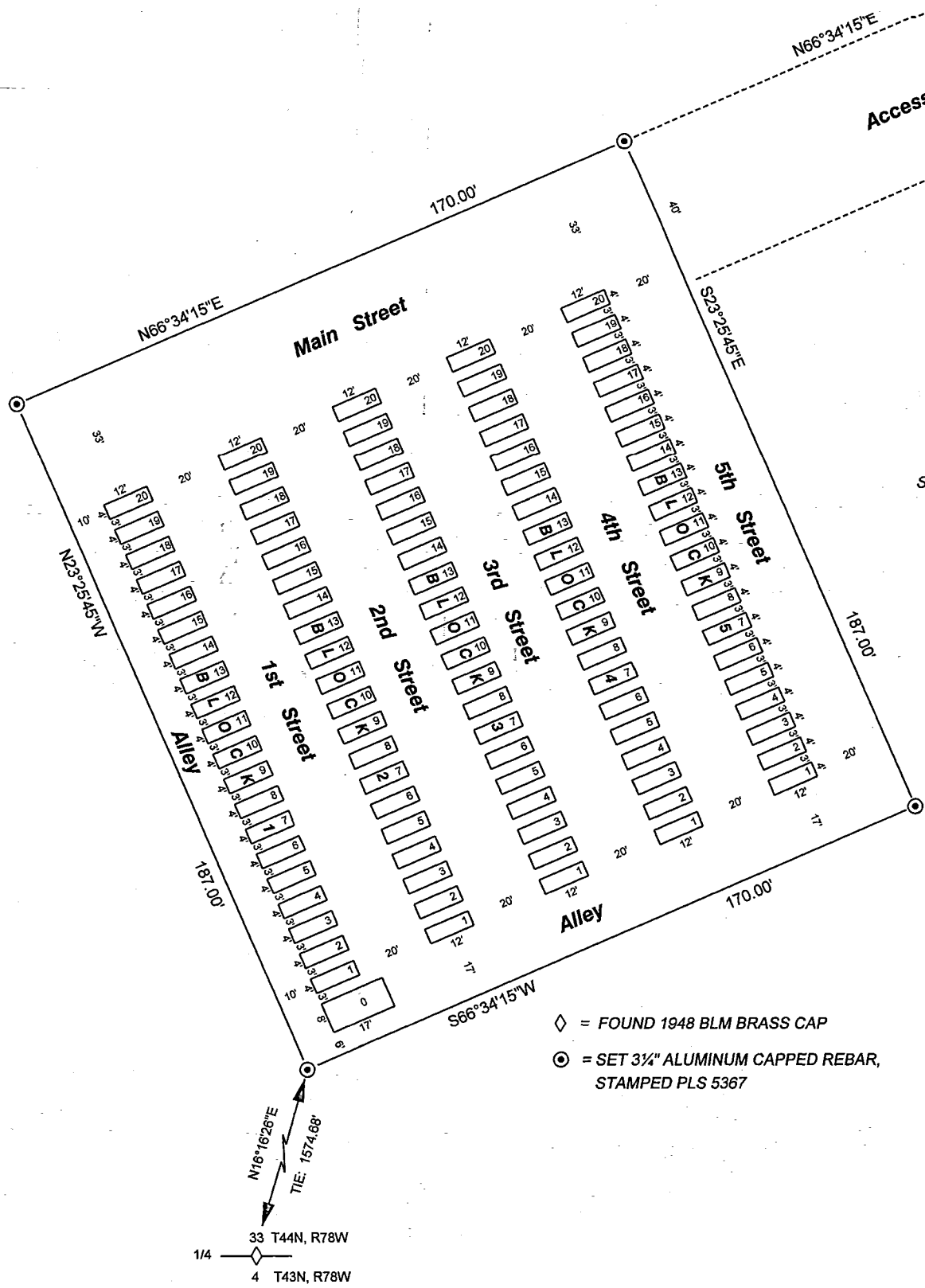


"THE DIVIDE" CEMETERY

CERTIFICATE OF DEDICATION

A TRACT OF LAND KNOWN AS "THE DIVIDE" CEMETERY LOCATED IN THE NW 1/4 SE 1/4 OF SECTION 33, TOWNSHIP 44 NORTH, RANGE 78 WEST, OF THE 6TH P.M., JOHNSON COUNTY, WYOMING, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING BLM BRASS CAP MARKING THE SOUTH QUARTER (1/4) CORNER OF SAID SECTION 33;
 THENCE N16°16'26"E A DISTANCE OF 1574.68 FEET TO A 3/4 INCH ALUMINUM CAPPED REBAR, STAMPED PLS 5367, SAID ALUMINUM CAPPED REBAR BEING THE TRUE POINT OF BEGINNING;
 THENCE N23°25'45"W A DISTANCE OF 187.00 FEET TO A 3/4 INCH ALUMINUM CAPPED REBAR, STAMPED PLS 5367;
 THENCE N66°34'15"E A DISTANCE OF 170.00 FEET TO A 3/4 INCH ALUMINUM CAPPED REBAR, STAMPED PLS 5367;
 THENCE S23°25'45"E A DISTANCE OF 187.00 FEET TO A 3/4 INCH ALUMINUM CAPPED REBAR, STAMPED PLS 5367;
 THENCE S66°34'15"W A DISTANCE OF 170.00 FEET TO THE TRUE POINT OF BEGINNING.

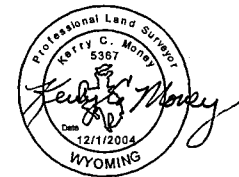
