### Conditions:

- Johnson County GIS data is distributed as is. The county will not responsible for re-projecting any GIS data.
  - GIS data will be provided in ESRI shapefile format AND will be projected as follows: **Wyoming State Plane, East Central Zone (FIPS 4902), NAD 83, US Feet**

### Restrictions:

- Government entities, educational entities, or public utilities: you will not resell, or distribute, the County GIS data.
- All other entities: you will not resell or redistribute the *County* GIS data without direct county consent.

### General Disclaimer and Restrictions for all entities:

- Data provided by the County is for the sole use of the user requesting the data. It is to be used in the conducting of its daily business.
- None of the data provided may be reproduced or redistributed without the County's consent. This limitation is not intended to restrict the User's distribution of printed documentation.
