POLLS OPEN 7:00 A.M. to 7:00 P.M.

August 6, 2018 is the last day to register to vote with County or City Clerk before Primary Election Day or Voter Registration is also permitted at the polls on Primary Election Day. Proof of identity will be needed to register to vote. Contact the Johnson County Clerk’s office for more details.

PROPOSITIONS: --“Shall Johnson County impose a Lodging Tax at the rate of 2% upon Transient Lodging at Hotels, Motels, Tourist Courts, Trailer Campgrounds, Dude Ranches, and Short-Term Condominium Rentals and similar establishments providing quarters or space for transient guests as set forth in Wyoming statute 39-15-203.”

CAMPAIGN REPORTING REQUIREMENTS

All **Candidates, Committees, and Political Action Committee**, except precinct Committeemen and Committeewomen, whether successful or not, must file a statement of receipts by August 14, 2018.

All **Candidates, Committees, and Political Action Committee**, except precinct Committeemen and Committeewomen, whether successful or not, must file a statement of receipts and expenditures by August 31, 2018. A successful candidate must file a Statement before receiving a certificate of nomination of election. Candidates for county and municipal offices file with the County Clerk, State or Legislative candidates file with the Secretary of State.
