Old Business: The auction for the items to be disposed of will be June 9<sup>th</sup>. Don asked for a list of what we would be getting rid of. Chancy Windsor of Pro Ag Services will be doing the weed spraying this year. The MBS investment meeting will be May 24<sup>th</sup> at 1:00.

New Business: Brad mentioned that the lawn mower is 9 years old, if we decide to replace it, it could also be put in the auction. The cost for a new machine would be \$4000-6000. Brad will talk to Dan at Rocky Mountain Equipment to see what we can get. Shawn made a motion to sell the current lawn mower at the auction and replace it with a new mower. Don seconded the motion.

The meeting room rules were reviewed and updated. Shaw will look in to getting password protection on the smart board. A meeting room form must be filled out every time the room is to be used. Brad asked for the board's backing of the rules when in question. Virgie recommended trying the rules for 6 months and making adjustments if needed. Shawn moved to sign the meeting room rules, Virgie seconded. Brad also purchased cleaning supplies for the meeting room.
