Minutes

January 14, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held at the Johnson County Planning Office, Buffalo, Wyoming on Tuesday, January 14, 2020. The meeting began at 7:03 a.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Scott McBride, Bob McBride, Mark Haines, Jim Hicks, Jeff Cope, Dennis Thorson, Commissioner Novotny, Shawn Sullivan, Barry Crago, Crosby Taylor, Floyd Whiting, Dave Harness and Karri White. A quorum was present.

I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on December 10th was made by Scott McBride. Seconded by Jim Hicks. Approved by all.

II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the December Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Mark Haines and seconded by Scott McBride. Approved by all. Discussion regarding the nurse payroll line item concluded with a need for communication with the hospital staff concerning the necessity of requesting a nurse transfer. Marilyn reported she completed an electronic form requesting FIB to add Treasurer Jim Hicks to the I-Corp online banking account. Jim will be contacted by the bank to facilitate this request.

III. BUFFALO REPORT:

1. Ambulance Calls

Dave reported December had 64 ambulance calls consisting of the following: 55 medical, 9 trauma and 9 transfers; 3 nurse transfers, 2 canceled, 16 patient refusals, 0 standby, 0 codes, and 0 trauma team activation. 47 in-town calls and 17 out-of-town calls. 56 were Johnson county residents and 8 non-residents.

IV. KAYCEE REPORT:

1. Ambulance Calls

Crosby reported there were 13 calls in December: 8 trauma, 1 medical, 0 standby, 1 public assist, 3 refusals, 1 canceled, 1 Life Flight, 0 ALS Intercept. Crosby informed the board he has 5 EMTs taking a hybrid online Advanced EMT class starting in February.

V. OLD BUSINESS:

1. Homeland Security Grant

As a requirement of the Homeland Security Grant, an online cybersecurity evaluation was completed by Marilyn Connolly, Crosby Taylor, Karri White and Shane Brown with DigeTeks. There are also Incident Command course requirements that need to be met.

2. Needs Assessment Study

SafeTech Solutions will present the Draft of the Needs Assessment Study on Monday, February 3rd at 4:00 p.m. at the County Planning Office.

3. Policies

Karri provided various policy drafts at the work session held January 9th. Barry Crago will review the policies, by-laws, and the medical director agreement. President Connolly asked that they be ready by the February regular meeting. It was suggested the board also review the County Handbook for their policies prior to making the final determination.

4. CPA Firms

Letters requesting bids for auditing services will be sent to CPA firms including Cloud Peak Accounting.

5. Insurance Coverage

North Wyoming Insurance provided a form to sign selecting the coverage for Wyoming uninsured motorists. Jim Hicks made a motion to approve the coverage at 1,000,000. Seconded by Mark Haines. Approved by all.

1. Election of Officers

Mark Haines made a motion to keep the current slate of officers: Marilyn Connolly as President, Jim Hicks as Treasurer, and Bob McBride as Secretary. Seconded by Jim Hicks. Approved by all.

2. EMS Billing Contract

Mark Haines made a motion to approve the agreement with EMS Billing Services, Inc. to transfer and assign all its obligations under the contract to Quick Med Claims. The billing company requested a letter of name change from the IRS. Karri will contact the IRS and request confirmation of the name change to Johnson County Rural Health Care District.

3. Request to Be Notified

Floyd Whiting with the Buffalo Bulletin emailed a request to be notified of all meetings and/or work sessions at least 24 hours in advance pursuant to Wyoming Public Meetings law.

4. Contract

A draft of a proposed contract for services between Johnson County Rural Health Care District and Buffalo EMS, LLC was presented by the RHCD Board. Barry Crago will make suggested revisions for the February regular meeting. Dave Harness is also working on a proposed contract to present to the Board.

5. Payroll Taxes

Crosby reported he received a letter from the IRS with a late fee for payroll taxes and the issue has been resolved.

6. Community Para Medicine License

Crosby asked the Board for authorization to pursue a Community Para Medicine License. It is a two-year training and licensing process and will allow the District to charge for calls that might otherwise be refusals. The Board gave him authorization to research the idea.

Vouchers were initialed, and checks signed by the board members. Report attached. There being no further new business, Bob McBride made a motion to adjourn the meeting. Seconded by Scott McBride. The meeting adjourned at 8:45 a.m.
