The regular meeting of the Powder River Fire District Board of Directors was brought to order by Chairman Fred Carr at 7:00 p.m. on Wednesday, March 11, 2020.

Fire Chief's Report:

Deputy Fire Chief Walker distributed his monthly report and entertained questions from the board. Craig also updated the board on recent vehicle repairs.

Craig reported that Noble Energy purchased five automated external defibrillators (AED) for the fire district. Craig requested approval to post a thank-you in the Kaycee Voice in appreciation of the generous donation, it was the consensus of the board to approve the ad in the paper. Call Outs: Deputy Fire Chief Walker reported that the district had responded to three call outs during the past month. All the callouts were for car wrecks.
