#### Johnson County Rural Health Care District

#### Minutes

#### April 13, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held via Zoom meeting on Monday, April 13, 2020. The meeting began at 5:05 p.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Bob McBride, Mark Haines, Jim Hicks, Scott McBride, Jeff Cope, Shawn Sullivan, Jill Wright, Michelle Chapman, Mark Bentley, Joel White, Kate Harness, Kelli Wilson, Shane Schrader, Dennis Thorson, Donna Nelson, Tom Newell, Crosby Taylor, Steve Freudenthal, Barry Crago, Jen Hicks, Robb Hicks, Dave Harness and Karri White. A quorum was present. Scott McBride made a motion to approve the agenda as written. Seconded by Mark Haines. Approved by all.

#### I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on March 10, 2020 was made by Scott McBride. Seconded by Jim Hicks. Approved by all. The motion to approve the minutes of the Special Meeting on April 2<sup>nd</sup> was made by Scott McBride. Seconded by Bob McBride. Approved by all.

#### II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the March Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Bob McBride and seconded by Scott McBride. Approved by all.

#### III. BUFFALO REPORT:

#### 1. Ambulance Calls

Dave reported March had 61 ambulance calls consisting of the following: 50 medical, 11 trauma and 16 transfers; 3 nurse transfers, 1 canceled, 18 patient refusals, 0 standby, 1 code, 0 DOAs, and 0 trauma team activation. 35 in-town calls and 26 out-of-town calls. 48 were Johnson county residents and 13 non-residents.

#### 2. Covid-19

Dave explained the Covid-19 PPE and response protocols. Karri requested verification Buffalo EMS may request supplies using the ICS-213R form. Karri reported receipt of an email by Commissioner Novotny indicating there were funds available to offset the costs of Covid-19 supplies.

#### IV. KAYCEE REPORT:

#### 1. Ambulance Calls

Crosby reported there were 5 calls in March: 2 trauma, 2 medical, 0 standby, 1 public assist, 0 refusals, 0 canceled, 0 Life Flight, 0 ALS Intercept. Crosby stated ambulance MS264 underwent emission repairs that were warrantied at Greiner Ford in Casper.

#### V. OLD BUSINESS:

#### 1. Bank of Buffalo

Marilyn stated the signature sheets for the Bank of Buffalo need to be signed by Scott and Bob McBride. Online banking access will be submitted.

#### 2. Radio Quote

Karri presented a quote from Communication Technologies in the amount of \$15,092.83 for seven P25 portable radios. Crosby has requested a quote for radio equipment as well and will have that available at the next regular meeting.

#### 3. Audit Proposal – Cloud Peak Accounting

A letter dated March 30 from Cloud Peak Accounting was received. They submitted a proposal to provide professional financial and compliance auditing services for the FYE June 30, 2020. The Board acknowledged receipt of the proposal and tabled the discussion.

#### 4. Connecting Point Quote

Karri presented a quote from Connecting Point for WatchGuard Basic Security Suite Renewal in the amount of \$478.70. Scott McBride made a motion to approve the quote for IT security. Seconded by Bob McBride. Approved by all.

#### 5. Policies & By-Laws

Barry Crago will email Karri the word document with the county by-laws so that she can make the necessary changes and present to the board for review.

#### 6. Contract with Buffalo EMS

Jim Hicks made a motion to immediately send a Request for Proposal (RFP) to other entities to provide ambulance service for northern Johnson County and to authorize applications for Director for \$70,000 – \$80,000 per year with benefits. Mark Haines seconded the motion. Scott McBride asked to go on record wanting to work with Buffalo EMS to negotiate a contract. Bob McBride agreed he would like to continue to negotiate a contract with Buffalo EMS. Dave Harness said he was willing to negotiate and work with budget constraints. After much discussion there was a call for question. Jim Hicks and Mark Haines voted aye. Scott McBride and Bob McBride voted nay. President Marilyn Connolly broke the tie by voting aye. Motion carried.

#### VI. NEW BUSINESS

#### 1. Certificate of Deposit

A certificate of deposit at First Interstate Bank will mature on April 30<sup>th</sup>. Bob McBride made a motion to have Treasurer Jim Hicks research rates and chose the best option to invest the money. Seconded by Scott McBride. Approved by all.

#### 2. Letter from Jo Co Fair Board

A letter dated March 11, 2020 from the Johnson County Fair Board was received. The letter requested ambulance standby for team penning, slack, youth rodeo and the rodeo performances. Scott McBride made a motion to charge \$1,500 for the standby services. For lack of a second, the motion failed. Jim Hicks made a motion to provide standby services for free for the youth rodeo and the rodeo performances on Saturday and Sunday. Mark Haines seconded it. Approved by all.

#### Call for new business:

#### 3. Ambulance Building

Jim Hicks made a motion for the chairman to appoint a building committee to build an ambulance barn in Buffalo and not spend more than \$500,000 with the money to be taken out of reserves. Seconded by Mark Haines. Scott McBride questioned how the RHCD was going to pay for it. Bob McBride did not agree with building a new building and questioned restrictions on reserves. Marilyn said this would not commit the RHCD to build a building it commits \$500,000 to be designated in reserves for a new building. Jim Hicks and Mark Haines voted aye. Scott McBride and Bob McBride voted nay. President Marilyn Connolly broke the tie by voting aye. Motion carried.

There was discussion how to proceed with contract negotiations. Jim Hicks and Scott McBride volunteered to sit in on a negotiation meeting with Dave Harness prior to the next regular meeting and report back to the board.

Vouchers were initialed, and checks signed by the board members. Report attached. There being no further new business, Mark Haines made a motion to adjourn the meeting. Seconded by Bob McBride. The meeting adjourned at 7:05 p.m.
