




Perry moved to approve the minutes of the March 3, 2020 regular meeting. Greenough seconded; motion carried.

After discussion with Road & Bridge on the Klondike Road remediation project, Greenough moved to authorize Chairman Novotny to sign Resolution #628, a Resolution to alter a portion of County Road Survey 12 to follow the current alignment of County Road 132, Klondike Road as it exists on the ground. Perry seconded; motion carried.

Perry moved to authorize Chairman Novotny to sign Resolution #629 a Resolution to alter a portion of County Road Survey 140 to follow the current alignment of County Road 132, Klondike Road as it exists on the ground. Greenough seconded; motion carried.


Other items discussed with Road & Bridge were future road remediation projects, Hazelton Road project bid and impact assistance with Klondike Road due to increased traffic.


Facilities Manager David Eads met with the Commissioners to give updates on safety precautions in the county buildings and protocols for sanitizing due to COVID 19.


Commissioner Special Meeting March 26, 2020



This meeting was held electronically via "Go to Meeting" for public access and participation.

After discussion, Greenough moved to authorize the Commissioners to sign Emergency Resolution #630, a Resolution Placing Limitations on Access to County Facilities. Perry seconded; motion carried.

Chairman Novotny called for public comment. Assessor Robinson thanked the Commissioners for closing the building to walk in traffic saying they would be working remotely from home and she is available from home by phone. Treasurer Bishop asked for new signage to be placed on the doors. County Attorney Tucker Ruby said this is about adhering to what Governor Gordon has in place and will allow the county to continue to provide services.
