# Minutes

#### May 11, 2020

# I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on April 13, 2020 was made by Scott McBride. Seconded by Jim Hicks. Approved by all.

## II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the March Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Bob McBride and seconded by Mark Haines. Approved by all.

#### III. BUFFALO REPORT:

#### 1. Ambulance Calls

Dave reported April had 49 ambulance calls consisting of the following: 36 medical, 13 trauma and 7 transfers; 1 nurse transfer, 0 canceled, 20 patient refusals, 0 standby, 0 code, 0 DOAs, and 0 trauma team activation. 31 in-town calls and 18 out-of-town calls. 45 were Johnson county residents and 4 non-residents.

# 1. Ambulance Calls

Michelle reported there were 4 calls in April: 1 trauma, 3 medical, 0 standby, 1 public assist, 2 refusals, 2 canceled, 0 Life Flight, 0 ALS Intercept. Michelle gave an update on the AEMT Class and stated radios were ordered and received.

#### V. OLD BUSINESS:

#### 1. Bank of Buffalo

Board signatures were acquired, and checks will be ordered with two signature lines. Online access will be set up soon.

#### 2. Contract with Buffalo EMS

Barry Crago reported the contract with Buffalo EMS is near completion with ambulance insurance and repairs and maintenance verbiage to be worked out. The litigation hold will be released by Buffalo EMS with the Board understanding and following the Wyoming schedule of retention for public documents. Release of responsibility/liability was discussed. Jim Hicks

made a motion not to provide a release of responsibility/liability to Buffalo EMS with the understanding Buffalo EMS will not provide a release to JCRHCD. Seconded by Scott McBride. Approved by all. Scott McBride made a motion to accept the contract negotiated with Buffalo EMS. Seconded by Jim Hicks. Approved by all.

The proposed budget figures were reviewed. A Special Meeting to set a preliminary budget, ambulance rates and a collection policy was set for Monday, May 18<sup>th</sup> at 4:00 p.m.
