Minutes

August 10, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held at the Kaycee Ambulance Building on Monday, August 10, 2020. The meeting began at 5:00 p.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Bob McBride, Jim Hicks, Scott McBride via phone, Crosby Taylor, Michelle Chapman, Mary Propson, Dave Harness via Zoom Audio and Karri White via Zoom Audio. A quorum was present.

I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Budget Hearing on July 13, 2020 and the Regular Meeting on July 13, 2020 was made by Jim Hicks. Seconded by Bob McBride. Approved by all present.

II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the July Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Bob McBride and seconded by Scott McBride. Approved by all present.

III. BUFFALO REPORT:

1. Ambulance Calls

Dave reported July had 104 ambulance calls consisting of the following: 77 medical, 27 trauma and 19 transfers; 3 nurse transfers, 3 canceled, 21 patient refusals, 2 standby, 0 code, 0 DOAs, and 2 trauma team activations. 62 in-town calls and 42 out-of-town calls. 79 were Johnson county residents and 25 non-residents.

Dave reported a family member had tested positive for Covid-19 and the necessary precautions and recommendations by Public Health are being followed. All active EMTs tested negative.

IV. KAYCEE REPORT:

1. Ambulance Calls

Crosby reported there were 5 calls in July: 1 trauma, 2 medical, 1 standby, 1 public assist, 2 refusals, 0 canceled, 0 Life Flight, 0 ALS Intercept, 3 total patients.

Crosby stated the July call volume was very low and MS264 continues to have mechanical issues.

V. OLD BUSINESS:

1. Accounting Firm

Porter, Muirhead, Cornia & Howard and Cloud Peak Accounting submitted

bids for the FYE 2020 audit. Scott McBride made the motion to accept the proposal by Cloud Peak Accounting. Seconded by Bob McBride. Approved by all present.
