

## Commissioner Meeting June 16, 2020

The regular meeting of the Board of County Commissioners was brought to order by Chairman William J Novotny III, at 9:00am on Tuesday June 16, 2020. Attending were Commissioners Linda Greenough and Robert Perry, Commissioner's Assistant Sheila Newcomb, County Clerk Vicki Edelman and Deputy County Attorney Barry Crago. This meeting was open to the public but held electronically via "Go to Meeting" for public access and participation as well.

Perry moved to approve the minutes of the June 2, 2020 regular meeting. Greenough seconded; motion carried.

Fire Warden Tiddle Camino met with the Commissioners to give updates on the Reno Incident Fire and request a partial fire restriction be signed. After discussion Perry moved to authorize Chairman Novotny to sign Resolution #636, a Resolution for Partial Fire Restriction. Greenough seconded; motion carried. Fire Warden Camino also reported he will be appointing Scott Duncan as the assistant fire warden.

Greenough moved to approve the 2019 tax year reduction for #3080 Journey's Photography in the amount of \$13.34 and #3079 Lytle Electronics in the amount of \$14.16. Perry seconded; motion carried.
