Minutes

September 14, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held at the County Planning Office on Monday, September 14, 2020. The meeting began at 4:00 p.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Bob McBride, Jim Hicks, Scott McBride, Mark Haines, Commissioner Bill Novotny, Aaron Palmer, Dennis Thorson, Michelle Chapman, Dave Harness and Karri White. A quorum was present. Jim Hicks made a motion to approve the agenda. Seconded by Scott McBride. Approved by all. Dennis Thorson requested to make a public comment to the board. President Connolly approved the request. Mr. Thorson referring to the Open Meetings Law stated the RHCD Board Members are elected officials and have a responsibility to residents to allow public comment and not censure negative comments.

I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on August 10, 2020 was made by Scott McBride. Seconded by Mark Haines. Approved by all.

II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the August Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Bob McBride and seconded by Scott McBride. Approved by all.

III. BUFFALO REPORT:

1. Ambulance Calls

Dave reported August had 94 ambulance calls consisting of the following: 76 medical, 18 trauma and 15 transfers; 3 nurse transfers, 3 canceled, 17 patient refusals, 6 standby, 1 code, 1 DOAs, and 1 trauma team activation. 49 in-town calls and 45 out-of-town calls. 65 were Johnson county residents and 29 non-residents.

Dave reported nurse transfers were increasing and providing nurses will need to be looked at further. There is an amount built into his annual budget but an increase in those types of calls will require a discussion with all involved. Dave suggested that Buffalo EMS receive a percentage of the nurse transfer income. The Board agreed that something needed to be done. Dave stated that losing nurse transfers would reduce care and RHCD would lose income. Sheridan Hospital is also increasingly requesting transfers as their local provider is on occasion not able to make the transfers.

IV. KAYCEE REPORT:

1. Ambulance Calls

Michelle reported there were 11 total calls in August: 2 trauma, 4 medical, 2 standby, 1 public assist, 4 refusals, 0 canceled, 0 Life Flight, 0 ALS Intercept, 6 total patients. Michelle stated MS264 has been repaired.

V. OLD BUSINESS:

1. Medical Director Agreement

The draft medical director contract with Dr. Schueler was discussed. It was decided to have attorney Barry Crago review the draft agreement and have it ready for the board and Dr. Schueler to sign at the next regular meeting in October.

2. Policies

Jim Hicks made a motion to approve the Travel, Credit Card, Electronic Resources, and Cell Phone Policies as written. Seconded by Mark Haines. Approved by all.

VI. NEW BUSINESS

1. HHS Phase 2 Grant

A letter dated August 13, 2020 from the Health Resources and Service Administration was discussed. The U.S. Department of Health and Human Services (HHS) is distributing payments in the Phase 2 General Distribution of the Provider Relief Fund to offer financial relief to providers impacted by coronavirus disease 2019. One point of eligibility is if we have not received General Distribution payments totaling 2% of our annual revenue. Karri will investigate the eligibility of the RHCD. President Connolly suggests keeping close track of COVID costs and grants. The loss of revenue we experienced is considered a cost.

Call for new business:

Vouchers were initialed, and checks signed by the board members. Report attached. There being no further new business, Mark Haines made a motion to adjourn the meeting. Seconded by Scott McBride. The meeting adjourned at 4:55 p.m.
