October 12, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held at the County Planning Office on Monday, October 12, 2020. The meeting began at 4:02 p.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Jim Hicks, Mark Haines, Commissioner Bill Novotny, Dennis Thorson, Crosby Taylor, Mark Bentley, Logan Williamson, Dave Harness and Karri White. A quorum was present.

I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on September 14, 2020 was made by Jim Hicks. Seconded by Mark Haines. Approved by all present.

II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the September Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Mark Haines and seconded by Jim Hicks. Approved by all present. Mark Haines authorized Karri White to transfer funds from First Interstate Bank to Bank of Buffalo, leaving \$5,000 in the FIB account. Karri will prepare a check and voucher for two RHCD Board members to approve and sign for deposit in Bank of Buffalo money market account.

III. BUFFALO REPORT:

1. Ambulance Calls

Dave reported September had 71 ambulance calls consisting of the following: 55 medical, 16 trauma and 10 transfers; 2 nurse transfers, 1 canceled, 9 patient refusals, 9 standby, 1 code, 2 DOAs, and 0 trauma team activation. 52 in-town calls and 19 out-of-town calls. 63 were Johnson county residents and 8 non-residents.

Dave reported four ambulances were in-service at the same time with backup last weekend that included a successful resuscitation.

IV. KAYCEE REPORT:

1. Ambulance Calls

Crosby reported there were 11 total calls in September: 4 trauma, 2 medical, 5 standby, 4 public assist, 2 refusals, 0 canceled, 0 Life Flight, 0 ALS Intercept, 7 total patients.

V. OLD BUSINESS:

1. Audit Update

The FYE 2020 Audit is nearing completion and Cloud Peak Accounting will present the audit at the November Regular Meeting.

2. COVID 19 Funds

Karri researched if the RHCD is eligible for Phase 2 General Distribution by the U.S. Department of Health and Human Services. It was determined due to the previous payment being larger than 2% of annual revenue the RHCD is not eligible.

The medical director contract along with the by-laws are being reviewed by Attorney Barry Crago.
