


Commissioner Meeting October 20, 2020

The regular meeting of the Board of County Commissioners was brought to order by Chairman William J Novotny, III at 9:00am on Tuesday October 20, 2020. Attending were Commissioners Linda Greenough and Robert Perry, Commissioner's Assistant Sheila Newcomb, County Clerk Vicki Edelman and Deputy County Attorney Barry Crago.

Greenough moved to approve the minutes of the October 6, 2020 regular meeting as corrected. Perry seconded; motion carried.

Bryce McKenzie 4-H Educator, Emma Pehringer, Kaitlyn Painter and Klarissa Painter met with the Commissioners to give updates and project information on the Johnson County 4-H program.

Greenough moved to rescind Resolution #637 and remove the partial fire ban for Johnson County. Perry seconded; motion carried.

Perry moved to authorize Chairman Novotny to sign Resolution #648, a Resolution to Increase the 20-21 FY Budget in the amount of \$239,240.00. Greenough seconded; motion carried.

Chairman Novotny called for Public comment regarding the Hazelton Road and parking lot issues. Landowners Dean Klein, Kent Waugh, Jeff & Becky Morgan, Barbara & Willard Bishop, Caleb Dillinger and Marilyn Vercimak expressed concern over the boulders around the parking lot, drifting snow, increasing the size of the parking lot, graveling the parking lot, signage closing the road & saying tracked vehicles required to travel down the road, the gate being moved to the top of hill and where WYDOT piles the snow since they now plow to the parking lot. Road & Bridge Supervisor Scott Pehringer stated the boulders were placed around the perimeter of the parking lot because the posts were being run over and destroyed. He also said the sign closing the road has not changed. Deputy County Attorney Crago said the County has the right to designate county roads as seasonal roads and has the right to keep the general public out in the wintertime. Tracey Weaver, Powder River District Ranger confirmed the Forest Services does have issues with people staying within the boundaries of the permitted parking area and getting the parking lot cleared at the time they are to be off the lot. She also stated the parking permit is due for renewal in 2021. Planner Waller and Commissioner Robert Perry suggested the landowners getting together and forming a tax district to help with the cost of plowing and road maintenance. After all comments had been heard, Chairman Novotny stated there will be no change in the seasonal road notice, the Commissioners will look at the rocks designating the parking lot boundary, the other debris along Hazelton road will be discussed with road & bridge, there will be no change in how the road is closed, public notice will be given on the permit dates and the Commissioners will discuss with WYDOT where they pile the plowed snow.


Tracey Weaver, Powder River District Ranger met with the Commissioners to discuss a Letter of Support for funding from the Land, Water and Conservation federal fund. The Forest Service is negotiating a possible purchase of a 100-acre parcel owned by Wayne Jones, depending on the appraisal with primary access through Grouse Mountain on the top. John & Laura DeMatteis expressed concern over it becoming public land and issues with fencing. Syd & John Long also adjoining property owners stated they would like to see it stay ag land and private. Wayne Jones stated it was his private property and he will sell at the appraised value. Commissioner Greenough stated it is not up to the Commissioners to interfere in private matters. The Commissioners agreed and no action will be taken.


After discussion with Planner Waller; Greenough moved to authorize Chairman Novotny to sign the Affidavit of Minor Boundary Adjustment between Geoffry L Spiering, Trustee of the Geoffry L Spiering Revocable Trust and Kathleen L Spiering Trustee of the Kathleen L Spiering Revocable Trust. Perry seconded; motion carried.

Commission Greenough recused herself from the next agenda item. After discussion with Planner Waller; Perry moved to authorize Chairman Novotny to sign the Affidavit of Minor Boundary Line Adjustment between Aaron C Rousey and Laura P Powell-Rousey and Mike W and Linda G Greenough. Novotny seconded; motion carried.

Greenough moved to authorize Chairman Novotny to sign Resolution #649, a Resolution Rescheduling the Commissioners Meeting from 11-3-20 to 11-4-2020. Perry seconded; motion carried.

Greenough moved to go into Executive Session regarding Potential Litigation. Perry seconded; motion carried. The regular meeting was back in session at 11:55am and was adjourned.
