

Commissioner Meeting September 15, 2020

The regular meeting of the Board of County Commissioners was brought to order by Chairman William J. Novotny, III at 9:00am on Tuesday September 15, 2020. Attending were Commissioners Linda Greenough and Robert Perry, Commissioner's Assistant Sheila Newcomb, County Clerk Vicki Edelman and Deputy County Attorney Barry Crago.

Perry moved to approve the minutes of the September 1, 2020 regular meeting. Greenough seconded; motion carried.

Perry moved to appoint Barry Gehrig, Incumbent to a 3-year term on the Harold Jarrard Park Board. Greenough seconded; motion carried.

Perry moved to appoint Sharon Miller and Lynn Young, Incumbents to 3-year terms on the Jim Gatchell Museum Board. Greenough seconded; motion carried.

Greenough moved to appoint Jim Gampetro and Nathan Williams, Incumbents to 4-year terms on the 1% Committee. Perry seconded; motion carried.

Greenough moved to appoint Laurel Foster to the Lodging Tax/Tourism Board for a 3-year term. Perry seconded; motion carried.

Chairman Novotny reported there will be a city/county board opening on the Recycle Board.

Greenough moved to authorize Chairman Novotny to sign the Boundary Line Adjustment between Chris George and Chad and Christi Danielson. Perry seconded; motion carried.

Planner Waller also discussed the Shores at Lake DeSmet subdivision issues, updates on septic permits, and subdivision inquiries.


After discussion with Facilities Manager David Eads, Perry moved to authorize Chairman Novotny to sign the Energy Retrofit Grant Contract Between the Wyoming Energy Authority and Johnson County in the amount of \$25,000. With a 10% grant match effective through June 30, 2020. Greenough seconded; motion carried. Mr. Eads reported this will be used to insulate the roof of the Old Historic Courthouse and the roof of the Museum has been funded by 1%.

4-H Educator Bryce McKenzie introduced himself to the Commissioners and gave updates on events coming up with the 4-H programs.

Marilyn Connolly, Emergency Manager met with the Commissioners to present the COVID19 after action plan and discuss the TextMyGov program.

After discussion Greenough moved to lift the hiring freeze and allow the Clerk to hire a position recently vacated. Perry seconded; motion carried. Greenough and Perry voted Yes; Novotny voted No.

There being no public comment; Greenough moved to the adjourn the regular meeting at 10:15am. Perry seconded; motion carried.

Commissioner Meeting October 6, 2020

The regular meeting of the Board of County Commissioners was brought to order by Chairman William J. Novotny III, at 9:00 am on Tuesday, October 6, 2020. Attending were Commissioners Linda Greenough and Robert Perry via the phone, Commissioner's Assistant Sheila Newcomb, Assistant Deputy County Clerk Brandi Carder, Assistant County Attorney Barry Crago. This meeting was held electronically via "Go to Meeting" for public access and participation.

Greenough moved to approve the minutes of the September 15, 2020 regular meeting Perry seconded; motion carried.

Sheriff Odenbach presented a modification of the Grant between Forest Supervisor, Big Horn National Forest and Johnson County Sheriff. This modification would be changing the funding, adding \$15,000.00 to the Grant. Greenough moved to ratify the Grant, Perry Seconded; motion carried. Odenbach also updated the Commissioner on two Grant approvals he had been working on; Phillips 66 Grant receiving a vehicle and AED Grant receiving AEDS pads.

After discussion on the 1st Draft of the MOU between Johnson County Wyoming and the Johnson County Prevention Council Linda asked to hold off at this time, get more updated information and put on the agenda next Commissioners Meeting.

Greenough moved to authorize Chairman Novotny to sign the Tax Reduction #3086 tax year 2020 \$120,305.18, Tax Refunds #3087 tax year 2020 \$896.96, #3088 tax year 2020 \$896.89. Tax Adjustments #3089 tax year 2020 \$645.00, #3090 tax year 2020 \$50.64 and #3091 tax year 2020 \$128.79. Perry seconded; motion carried.

Greenough moved to authorize Chairman Novotny to sign the Contract between Wyoming Department of Health, Public Health Division and Johnson County for the Public Health Officer beginning July 1, 2020 thru June 30, 2021 in the amount of \$9,600.00. Perry seconded; motion carried.

Lake Desmet Shoreline Advisory Board had discussion with the Commissioners about a piece of property on the shoreline that had multiple improvement on it by the landowner. They advised the Commissioners the improvements were being made on the shoreline without permission. Landowner Moorland will not comply with the Advisory board on what he can and cannot do. The Advisory Board also asked if they could update their Handbook. Greenough moved to make improvement to the Lake Desmet Shoreline Handbook and Perry Seconded; motion carried. Greenough also moved to have County Attorney Crago draft a letter giving the Landowner 10 day to update the property to its original status. Perry Seconded; motion carried.

Greenough moved to approve the October vouchers in the amount of \$1,096,041.30. Perry seconded; motion carried.
