Minutes

December 14, 2020

The regular monthly meeting of the Johnson County Rural Health Care District was held at the County Planning Office on Monday, December 14, 2020. The meeting began at 4:00 p.m. The meeting was called to order by President Marilyn Connolly. Present were Marilyn Connolly, Jim Hicks, Scott McBride, Marie Miller, Barry Crago, Crosby Taylor, Michelle Chapman, Aaron Palmer, Logan Williamson, Dave Harness and Karri White. A quorum was present. Jim Hicks made a motion to approve the agenda. Seconded by Scott McBride.

I. APPROVAL OF MINUTES OF LAST MEETING:

The motion to approve the minutes of the Regular Meeting on November 9, 2020 with two corrections was made by Marie Miller. Seconded by Scott McBride. Approved by all present.

II. VIEW AND APPROVE TREASURER'S REPORT:

Jim Hicks presented the November Treasurer's Report for review. Motion to approve the Treasurer's Report was made by Scott McBride and seconded by Marie Miller. Approved by all present.

III. BUFFALO REPORT:

1. Ambulance Calls

Dave Harness reported November had 75ambulance calls consisting of the following: 58 medical, 17 trauma and 13 transfers; 5 nurse transfers, 2 canceled, 17 patient refusals, 1 standby, 0 codes, 2 DOAs, and 0 trauma team activation. 45 in-town calls and 30 out-of-town calls. 64 were Johnson county residents and 11 non-residents. Dave expressed concern with the increase in transfers and the affect it has on payroll expenses and asked to Board to consider some time of compensation to Buffalo EMS if transfers, especially long distance, continue to rise. He also advised the Board that MS106, the transfer ambulance, will need to be replaced soon. There was discussion regarding rotating ambulances and the equipment needed for a transfer ambulance. It was decided to discuss both issues at the next regular meeting.

IV. KAYCEE REPORT:

1. Ambulance Calls

Crosby reported there were 15 total calls in November: 6 trauma, 4 medical, 0 standby, 0 public assist, 5 refusals, 0 canceled, 0 Life Flight, 0 ALS Intercept, 10 total patients.

V. OLD BUSINESS:

1. Liability Insurance Renewal

Marilyn Connolly met with Trevor Moon with North Wyoming Insurance and Barry Crago regarding the RHCD liability insurance. There were a few changes made in the application regarding ambulance values and number of employees.

2. HIPAA Policy

It was discussed that the RHCD should have a blanket HIPAA policy for both services. Marilyn submitted a draft HIPAA policy. Karri provided a copy of what Buffalo EMS currently uses but indicated changes need to be made. Barry Crago will review the policies and make a recommendation to the Board.

3. Medical Director Contract

Dr. Schueler provided the Board with suggested changes and concerns with certain items in the Medical Director Contract. Dr. Schueler is researching options for malpractice insurance. Marilyn made changes to the contract after the first draft and will send updated draft to the board members. Marilyn will contact the State Office of EMS for direction on what is required of the Medical Director.

Marie Miller made a motion to appoint Scott McBride as President. Scott declined the nomination. Jim Hicks made a motion to appoint Marilyn Connolly as President, Jim Hicks as Treasurer, and Marie Miller as Secretary. Seconded by Scott McBride. Approved by all present.

A schedule of meeting dates, times, and places was provided continuing the current schedule of the second Monday of the month at 4 p.m. in Buffalo with the April, August, and December meetings at 5:00 p.m. in Kaycee.

3. Cyber Security Evaluation

Marilyn spoke with DigeTekS regarding the required Cyber Security Evaluation. They said they would be able to perform and submit the evaluation.

Marilyn reminded everyone to contact First Interstate Bank, First Northern Bank, and Bank of Buffalo to provide information and signatures for the various accounts.
