Barnum Inc plans to start work on the Town/HJP project next week and hopes to have it completed in about 3 weeks depending on the weather. 90% designs for the 3 diversions should be completed by next week and we will meet with landowners to review them before they are finalized. All 3 diversion projects have their Corp permitting. The only documentation missing is the landowner agreement with Renkert for the Moffett diversion.
