Perry moved to approve the Catering Permit requested by Cowboy Saloon for the dance on their back patio on August 7, 2021. Greenough seconded; motion carried.


Greenough moved to approve Emergency Manager Marilyn Connolly's grant reimb request in the amount of \$345.00. Perry seconded; motion carried.
