Minutes from the May meeting were reviewed. Travis moved to accept the minutes. Jay seconded. Motion carried. The bank statements for May have been reviewed and found to be in order and reconciled.

In old business, Zach told the board about Household Hazardous Waste Day. The event went well. We had 14 volunteers plus employees from Veolia, the Johnson County Solid Waste District and the city of Buffalo. Collection numbers are similar to past years with the number of residents possibly dropping. Didn't seem to be ask many vehicles this year. All in all, it was a great event.

Ryan and Zach attended the Johnson County Commissioners Budget Meeting where they asked for the full mill. Commissioner Novotny also explained how the ad valorum tax situation will be moving forward.

Soil sample testing has been conducted in the office this year. We had twice as many tests this year that were done. Amanda did the testing and evaluations. This is something we can do for the residents of Buffalo now without sending it out of state.

The Community Orchard planting went well. It was held June 1. The district was there to help plant trees and do activity stations for the children from the Boys and Girls Club.

Field office activity as well as district personnel reports were given.

In new business, Ryan and Zach discussed our Risk Management and Bonding procedures for base appropriation funding. Ryan signed the documents for both.

The EWP, Last Chance Ditch, update was given. Zach has secured the Army Corps permit, has the temporary use permit signed and ready and is doing the cultural clearance tomorrow. There is one more visit regarding Ute Lady's Tress. 7 contractors had asked for bid packets. We are conducting one more site visit and will be selecting a contractor at the next board meeting.

We have received funding from WWNRT for the HIP project. That is working forward.

The Hess Invasive Weed Treatment project is in the final stages. They are working out the weed treatments and deciding on which herbicide to use.

The Zezas Pipeline Project has started. Zach has been in tough with the engineer on the reimbursement process.

Zach met with the new director for the Plank Stewardship Initiative. Brook Swank is the new director and we look forward to working with her.

The Sheridan Research & Extension Center is having their field day on June 30th this year. It is a good way to get out and see what research is going on with cheat grass as well as other invasive species.

Our July board meeting will be held On July 13<sup>th</sup>. Remember we will be having our budget hearing as well as selecting a contractor for the EWP project.

In other business, Virgie moved to give \$50 to the Wyoming 4H Foundation which will be contributed to the Natural Resource section of the 4H program. Travis seconded. Motion carried.

Commissioner Novotny gave a county update to the board.

We had no correspondence for the board this month.

With no further business, Travis moved to adjourn the meeting at 7:25 pm.
