## Johnson County Cemetery District Minutes February 8th, 2022

The regular monthly meeting of the Johnson County Cemetery District was held at The Willow Grove Cemetery in Buffalo, Wyoming on December 14th, 2021. #### I. PUBLIC COMMENT:

Barbara Mueller presented signed petitions. 1316 signatures on this petition for rescinding Saturday Burial Fees and refund those who have paid this fee.

Honey Harriet talks and wants the Saturday Burial Fee rescinded.

Doug Wasinger thinks the Saturday Burial Fee is a burden and is out of line with the values of the community and wants the fee rescinded.

Paul Gilbert states that this Saturday Burial Fee will not solve management problems for the Cemetery District and wants the fee rescinded.

Lisa Norman says that rescinded the Saturday Burial Fee is the right thing to do.

Carla Bishop thinks it is very important that people can have burials on Saturdays and want this fee rescinded. Carla also offered the Johnson County Facebook page to advertise for cemetery employee recruitment. Craig Wetterlund reads a letter from Terry & Lynn Ridgeway wanting JCCD to rescind Saturday Burial Fee. Dave Harness wants the Saturday Burial Fee rescinded.

Shane Schrader warns about the legacy the JCCD board is leaving and wants the Saturday Burial Fee

rescinded.

Comments from Zoom attendees; Luke Goddard wants the Saturday Burial Fee rescinded.

- II. VOUCHER: John Hansen moves to accept vouchers and Carolyn Fox seconds. No discussion about vouchers There was a vote and motion carried.
- III. MINUTES: Craig Wetterlund makes a motion to approve the minutes. John Hansen seconds the motion. No discussion. There is a vote motion carried.
- IV. GUEST SPEAKERS: Jennifer Romanoski gave background on echoes of the past events that have been held in the Willow Grove Cemetery. She also asked the board if these could happen again in the cemetery. The board consensus was yes and approved for these for this year.

#### V. TREASURER'S REPORT:

Chanda went over the financial report. Chanda reports that JCCD has expended 58% of what has been budgeted. She also states there have been line item over runs but money has been moved to cover these. John Z asks if there is a motion to approve the financial report and submit to the board? John Hansen makes a motion and Craig Wetterlund seconds. No discussion. There is a vote, motion carried.

John Ehlers discusses preliminary budget and his is handed out to boar4d members to review for the next meeting.

# VII. WILLOW GROVE SEXTON'S REPORT:

Van Frazier gives and update on various JCCD Cemetery projects. The meeting room remodel has started and is almost finished. Megan doing research on irrigation system sprinkler head replacement costs for Willow Grove Cemetery.

There is a mower at the dealer getting repaired. The dealer found more leaks than what was thought as well as a wheel spindle that has been ruined.

Cemetery staff has been registered and will be attending the WGGA conference in Casper 2/16 through 2/17

Cemetery truck has been in the shop for repairs and new tires.

Meagan and Van went to Gillette to tour the cemetery and talk to Darin Edmonds about how their cremation gardens look and how it interact with CIMS.

Ordered new heat pump/air conditioner for the shop break room and it came in and was replaced.

# VIII. KAYCEE SEXTON'S REPORT:

Van states there nothing out of the ordinary to report for Kaycee Cemetery.

- 1. Vendor policy. This will be tabled until next month.
- 2. Strategic Plan work session is scheduled for 3/1/2022 at noon and pick up starting with page 5 of the draft.
- 3. JCCD has received the completed plan set from CPRA and they will be shelved at this time.
- 4. John Ehlers makes a motion to delete article 3.5B through 3.5F which will do away with compensatory time for JCCD staff. John Hansen seconds the motion. No discussion and a vote. Motion carried.
- 5. Van Frazier proposes a flat rate pay schedule for Saturday Burials for JCCD staff and part time/seasonal employees. The flat rate pay was dropped for JCCD permanent staff and it was decided this would be paid as overtime. John Ehlers makes a motion to accept the \$125.00 flat rate for payment for part time and seasonal staff for each burial they help with on Saturdays. John Hansen seconds the motion, no discussion and a vote. Motion is carried.

# XII. NEW BUSINESS:

- 1. Craig Wetterlund makes a motion to rescind the JCCD Saturday Burial Fee and refund the money that families have paid since it has been in place. John Hansen seconds the motion. There is discussion on how this does not solve the problem that the Cemetery District has. There is a vote. Craig W. votes yea, John H. votes yea, Carolyn F. abstains, John E. votes nay, John Z votes nay, Nancy E. not present to vote. Vote is a tie and motion failed.
- Heated office for the Kaycee shop was discussed. Craig Wetterlund makes a motion to get price quotes for this office, John Hansen seconds the motion. There is discussion about how this should be done through strategic planning process. Vote takes place. Craig W. votes yea, John H. votes yea, Carolyn F. votes yea, John Z. votes yea and John E. votes nay. Motion is carried.
- 3. There was a consensus of the board for approval in getting price quotes for converting the old log building into a Willow Grove directory building and for price quotes on building a handicap ramp/doorway to meet ADA standards for the new office.
- 4. Amendments#23 to Article #5 JCCD Policy and Procedure Manual to correct grammatical errors was approved the board with general consensus. Amendment #21 to Article 3 JCCD Policy and Procedures Manual to correct grammatical errors was approved by the board with general consensus.

There being no further business, the meeting adjourned at 3:52 P.M., following a motion by John Hansen and seconder by Craig Wetterlund.

The next meeting will be March 8th at 2:00 PM at the Willow Grove Cemetery Business Office.

Amendment #22 to the Johnson County Cemetery District Policy and Procedures Manual dated January 11, 2022

# Article 5 as reads:

Article 5: Digging of graves and preparation for graveside services:

- The only person allowed to spot and dig in a cemetery in Johnson County will be the Sexton or employed cemetery crew or a contractor contracted by the Cemetery District to dig a grave in a cemetery other than Willow Grove.
- Graves will be dug with a backhoe with rubber tires or Sexton approved machinery and the dirt shall be removed until the burial is complete.
- Graves will be dug to a specification of the cemetery Sexton. To wit: no larger than 4 feet wide and no longer than 8 feet with a depth no greater than 6 feet the exception of double burials in the new Veteran's section.
- The cemetery will provide the cost of open and closing the grave; a tent with or without walls, chairs for the family members and a lowering device to facilitate lowering the casket into the grave.
- During graveside services all machinery will be respectfully shut off during the duration 5. of the service.
- In so much as possible the cemetery sexton staff must be given at least 48 hours prior notice with proposed burial time and locations.
  - b. Requestor is responsible to complete and furnish the form "Johnson County Cemetery District Burial Order" as part of the proposed burial service application process.

# Article 5: Hours of operation:

  - b. Requestor (funeral Home or representative of the family) is responsible to remit any and all related fees for the requested services, prior to Burial Permit being issued, and the grave being dug.

# Article 3 as reads:

**Article 3: Hours of Operation** 

- There will be no admittance into the Willow Grove Cemetery before sunrise or after sunset.
- 2. No person shall be allowed in the cemetery after dark with the exception of a funeral director conducting funeral business or for purposes of physical emergency unless approved by the cemetery board.

- 3. All Johnson County Cemeteries will observe the following list of federal holidays and observed holidays. When a holiday fall on a Saturday the proceeding Friday will be observed also. When a Holiday falls on a Sunday the following Monday will be observed also.
- 4. No burials will be permitted on these dates or the observed dates.
  - 1. January 1st-New Year's Day
  - 2. Equality Day-Observed on the third Monday of January
  - 3. Presidents Day-Observed on the third Monday of February
  - 4. The Saturday before Memorial Day
  - 5. Memorial Day -Observed on the last Monday in May
  - 6. Independence Day- July 4th
  - 7. Labor Day-Observed on the first Monday of September
  - 8. Columbus Day- Observed on the second Monday of October
  - 9. Thanksgiving Day- Observed on the fourth Thursday of November
  - 10. Christmas Eve- December 24th
  - 11. Christmas day- December 25th
  - 12. New Year's Eve- December 31st
  - 13. Upon declaration by the Governor of Wyoming, any date appointed or declared and approved by the Johnson County Cemetery Board.
  - 14. Any date appointed or declared by the president of the United States as an occasion of national mourning, rejoicing or observed national emergency.
  - 15. All other Holidays proclaimed by the Johnson County Cemetery Board.
