- Spring Insert Ad Madden Media Fox stated the JCTA ad has been submitted for the Spring Insert Program with Madden Media. The insert will go into thousands of newspapers across the country. Miller feels that while the program is expensive, it is worthwhile to continue.

New Business:

- Grants Fox stated the 2017 grant forms have gone out to previous recipients of the program, the form has been added to the BCC website, and been made available on the Chamber's social media platforms. The ads have been placed with the Buffalo Bulletin. The deadline to submit grant applications is the end of February, hearings will be held at the March JCTA board meeting.
- Election of Officers Board members present discussed leaving the board officers the same. Becker motioned the officers carry over to the next year as they are currently, Bradley seconds. Motion carries.
- Time Square Video Fox stated a film crew visited Kaycee, and compiled a video that was shown in Time Square in NYC. The videos were filmed for a program called 'Time Square Minutes'. The BCC was provided the links to the videos from the producer, and have been granted permission from the producer to use them for tourism purposes.
- Douglas, WY Billboard Fox stated the new wrap is in the process of being installed.

• Pathfinder magazine – Fox stated the ads are being sold now. Fox informed the board Kaycee, WY will have its own section in the new Pathfinder magazine, there will be ad lookup pages with color coding, and that there have been no difficulties with this year's publication process.

Henry stated Lodging Tax numbers appear to be down significantly, something to keep in mind when the board is budgeting for the next year. Fox stated part of the problem could be the changes to the collection system itself. Collections paid by the 15th of each month now result in a kickback to the paying establishment, some businesses are paying quarterly, more establishments are only open seasonally, etc. Fox also stated there was a significant bump in a prior year when internet sales were 'back' collected for a long period of time all in one year, and this 'bump' makes normal collection amounts look less than what might be expected. Henry also feels the numbers were skewed by the internet lodging tax collection bump, and that collections are not down as much as they appear to be based on figures that exclude the bump from the internet tax collections. Johnson said if you look from month to month collections appear to be down slightly. Henry also feels all collections paid quarterly may not have been collected yet.

- Becker motions to accept financials as presented, Knapp seconds the motion. Motion carries.
- February Bills Becker motioned to approve the February bills, Bradley seconds, motion carries.
- March Bills –Knapp motioned to approve the March bills, Becker seconds, motion carries.

Old Business:

- Kaycee Billboard Update —Fox stated Dave Stallwood will begin work on the billboard when he returns to the area. Fox asked the board to be thinking about ideas for the vinyl as the board will need a new wrap when it is rebuilt, and this will need to be considered in their next budget. Knap said he may have a funding option to pay for the vinyls, he will check on this funding option and report at next meeting. The board then discussed making repairs to the Ft Phil Kearny billboard. This billboard currently has a painted wood front.
- Douglas Billboard Update The vinyl is ready to be installed, installer is waiting for a break in the weather to physically be able to get to the billboard.

 looked good.
- Kaycee Billboard Alternate Funding Knapp was checking on alternate financing for billboard wraps and installation, as he was not at the meeting the Chamber office will contact him on behalf of JCTA and get information from him regarding the funding.
- Grants McCormick stated the letter have gone out to all organizations who applied for grant monies. Johnson stated he has heard from a group that did not receive funding. Board discussed why this organization was not granted funds (grant application was not 'completed' as required of all organizations requesting funds, and the event(s) didn't fit the criteria of 'heads in beds' to receive grant money).

New Business:

Cantina Mural – Fox stated the JCTA board had asked for the mural project to be added to the April agenda so the board could discuss funding options, as the board felt this project is more of a long-term investment rather than strictly a marketing project and would like to review funding options. Fox stated two grants have been written for funding on the project. Buffalo Chamber of Commerce will be working with the City of Buffalo on a Community Enhancement grant. The mural project will cost over \$60,000.00. The completed mural will be a 'Welcome' to Buffalo visible from the intersection of Fort and Main Streets, and is a continuance of the previous mural project completed by Vision Buffalo. Fox presented pictures of the proposed mural design. Fox stated the business owner will fund the painting of the flat, base coat using the special paint required for the murals to be painted on. Board decided to delay a decision on funding until the grants results are available. If JCTA decides to help with funding, the funds will be contingent on grant monies received for the project. Questions asked by the board were as follows:

- Who will own the artwork?
- What happens if the building owner decides to paint over the mural?
- Who is responsible for maintenance/repairs of the mural?
- Could these responsibilities be transferred to a new owner in the event the current owner should decide to sell the building?

Fox stated she would research the concerns of the board regarding the above questions.

Johnson County Jim Gatchell Memorial Museum: Sylvia Bruner made a presentation to the board regarding the program planned by the museum to mark the 125th Anniversary of the Johnson County Cattle Wars. The museum will be working in conjunction with the TA Guest Ranch to hold a weekend of activities regarding the Cattle Wars. TA Ranch was declined on their request for funding due to them being a private business. The board discussed granting funds to the Museum for the program. Becker motioned that the JCTA grant \$3000.00 to the Johnson County Jim Gatchell Memorial Museum for advertising their September programs regarding the 125th Anniversary of the Cattle Wars. Bradley seconds the motion. Motion carries.

Board Decision: Move \$3000.00 from the advertising budget to the community grants budget.

Regular board meeting ended at 2:50, presentations for advertising began at 2:51.
