Miller suggested a survey of local lodging properties (How did you hear about Buffalo?) to narrow down what marketing is working for county tourism. Knapp would like more information about MultiView in advance of the next budget session. Knapp would like to know if we are using MultiView to best benefit of county tourism. Smith will be looking into MultiView product and their provided services. Anton would like to see more marketing aimed at the 'shoulder' season in Johnson County. Anton thinks the tourism numbers for summer are 'what they are going to be, we are already full in the summer', and would like to see the focus turn to tourism opportunities in the fall/winter months.
- Budgeting In regard to marketing, Knapp would like to see yearly budget preparation begin sooner rather than later. Miller feels the board could start their reviews at the December meeting. Knapp would

like to consider funding for the Satellite Information Center in the next fiscal year budgeting as city and county funding is getting more difficult to obtain.
