**REVIEW/ACCEPT MEETING MINUTES:**

# **II.Regular Business:**

# Financials:

Financials reviewed by Chairman R. Myers. Review of actual versus budget. John Camino explained the financials. Discussed meeting dates and how they effect getting the financials done on time. How it is important to get all the bills entered and reconciliation completed before financial reports can be run. Chair Myers suggested the board may want to consider changing the meeting dates to the 3<sup>rd</sup> Wednesday of each month. Chair continued review of financials. J. DeMatteis motioned to approve, Z. Smith 2<sup>nd</sup> and motion carried.

Chair Myers gave a treasurer's report of the budget versus actual at the 6 months mark. Noting that we are running around 58% of our budgeted expenses and 58% of our income. It may be necessary to file an amended budget with the state. By the 10<sup>th</sup> month in the fiscal year, we need to file the amended budget if warranted.

#### **Staff Report:**

Staff K. Absetz -Recap of the visitors Bomber Mountain Civic Center for 2022 30,000 visitors. Powder River plumbing reduced the downstairs plumbing bill by nearly \$600. Wendy Smith and Claudia Todd are working together to revitalize the Johnson County Leadership program. K. Absetz has officially begun taking on bookkeeping responsibilities. Saving JOCO First \$389 per month. Still waiting for a bid on installing new fire panel in the building. Reviewed the community calendar "johnsoncountywyevents.com" and justifying the \$1885 expense. It is very hard to get content for and too time consuming to hunt down relevant content. We are competing with various other entities that are providing their version of a community calendar. W. Smith asked guest J. Sauers how JCTA directs questions for events. After much discussion further research will be done to get the JOCO community calendar up to date. Possibly restructure it so that event coordinators can simply add to the calendar. Reach out to JCTA, Chamber of Commerce, Fairgrounds, Buffalo Bulletin, and School board. Calendar initiative to happen prior to next board meeting.

#### **III.PUBLIC COMMENT PERIOD:**

Ben Hostetler speaks on the current condition of Mountain Meadow Wool located at 22 Plans Drive; a property owned by JOCO First. Discussed items that need to be addressed and possible expansion of facility.

Wendy Smith delivers an update of Sheridan College in Johnson County. Current enrollment for the spring semester. The revamp of furniture in the college wing.

**Update of RFP for grant.** Looking to get county and city officials involved. We are still at step one.

Discussion of how to handle employee benefits. Chair Myers suggested using the Johnson County employee handbook. S.
