Kevin Lund moved to approve the Treasurer's Report, the November Savings account reconciliation, the December Checking Account reconciliation and to accept payment of all bills. Wade Curuchet Second. Motion Carried.

BUSINESS:

1. State Forestry Hazardous Tree Removal Grant

-Anita Bartlett stated that she had been working with WY Sate Forestry on a grant to remove hazardous trees and to prune the deadwood out of remaining trees on public property in town limits. These trees are predominantly located in the Town Park. This grant would cover the cost of removal. The grant is due in March.

2. Game & Fish Department Grants

-Anita Bartlett has been working with Travis Cundy of WY Game and Fish to procure engineering grants. The fist grant would be for engineering to replace the Modoc Diversion with a cross vane structure opening up the last of the Middle Fork of Powder River above the Sahara Diversion. The District would meet the cost share match for this grant through in-kind services administrating the grant. The second grant was to be to assist with cost associated to engineer the Town Streambank Restoration Project near the wastewater treatment facility. However, due to issues with eligibility for the FEMA BRIC Grant this application has been put on hold for a year.

3. FEMA BRIC Grant

-Anita Bartlett stated that the purpose to apply for this grant was to cover the bulk of the cost to engineering the Town Streambank Restoration Project near the wastewater treatment facility. However, we are not eligible to apply for the grant this year. In order to apply the District has to have participated in and approved the County Hazardous Mitigation Plan. The 2023 plan is not approved by FEMA as of yet so the District can not approve it and the District did not participated in the 2018 plan. Once the 2023 plan is approved by FEMA the District will adopt it which will make the District eligible in the future.

4. Election of Officers

- Anita Bartlett informed the board that it was once again time to elect officers for the District. Wade Curuchet moved to retain the current slate of officers: Bill Jones-Chair; George Renkert-Vice Chair; Wade Curuchet-Secretary/Treasurer. Tom Harlan second. Motion Carried.

5. WDA Reorganization Form

-Anita Bartlett presented to the board the WDA Reorganization Form. She asked the board to review their information for any corrections that needed to be made. No corrections were found, and Anita said she would get the form turned into the WDA and WACD.

6. District Report

-The District Manager's Report was discussed.

7. NRCS Field Office Report

-The NRCS Field Office Report was discussed.
