The Johnson County Library Board of Trustees met at Johnson County Library in Buffalo on Tuesday, February 20, 2024. The following members were present: Jennifer Bakken, Margaret Smith, Shane Greet, Leighton "Pitchy" Gammon, and Terry Urruty. Director Lindsey Belliveau and Assistant Director Robin Romine were present. Jenny called the meeting to order at 4:09 p.m.

New Business

- Discussion on potentially implementing Interlibrary Loan (ILL) fees
 - The director explained that we currently have a \$250 budget/month for postage for all ILL materials. This year we will go over that amount due to an increase in postage and the quantity of ILLs being requested. The library does receive a reduced rate from the post office for library and media mail. It's a wonderful service libraries across the state all work together to provide access to items for patrons. Several other libraries in the state charge to help with or completely cover the cost of postage for these items. Our current policy is one item/patron at a time, but this policy is something we are no longer able to abide by due to statewide library services, and Patrons are now requesting more ILLs on their online. If we are to charge for ILLs, we would need to let our patrons know via postings, website, Facebook, etc. \$1-\$2 per item would not cover the postage, or even half of the postage but it would help to stay within budget. Currently, we consider purchasing any items that have been requested twice, and this does help us to aquire items patrons are wanting regularly. Another thing to consider is that many patrons would like the option to pay via credit card. At this point, the fees and accounting tracking may be too great.
 - Pitchy moved to charge \$2.00 per ILL item, while giving the director time to work out financial discretion, going into effect 5/1/24. Margaret seconded the motion.
- Discussion regarding computer replacement
 - Margaret is concerned that computers are not being replaced per our computer replacement schedule.
 Lindsey shared that the company we work with has recently gone through a large transition. We will discuss computer replacements with them in the coming months as they return to regular service.
