Commissioner Meeting March 5, 2024

The regular meeting of the Board of County Commissioners was called to order by Commission Chairman William J. Novotny, at 9:00am on Tuesday, March 5, 2024. Attending were Commissioners Jeff Shelley & Bob Perry, Commissioner's Assistant Jody Telkamp, County Attorney Tucker Ruby, and County Clerk Jackie Camino.

The attendees recited the pledge of allegiance. Chairman Novotny introduced Wyoming's Governor Mark Gordon. Governor Gordon performed the swearing in ceremony, officially appointing Jimmy Cataline as Johnson County's Emergency Management Coordinator. Governor Gordon also provided an overview of the status of the current session of the Wyoming State Legislature. Retiring Emergency Management Coordinator Marilyn Connolly was presented with a flag flown over the State Capitol in appreciation of her years of service to Johnson County.

Chairman Novotny called for a motion to approve the minutes from the March 5, 2024, meeting. Commissioner Perry moved to approve as presented; Commissioner Shelley seconded, and the motion carried.

The scheduled liquor license hearing convened at 9:31a.m. Clerk Camino presented the application submitted by Rock N' Roll Ranch, LLC dba The Stampede for a Malt Beverage License. Camino explained that The Stampede was recently issued a Malt Beverage License, and that it's now up for renewal. The owner/operator had since established an LLC and wanted the license to be issued to the newly formed entity. Upon the advice of the Wyoming Liquor Division, in lieu of a renewal application, they submitted a new application for the Malt Beverage License in the name of the newly formed LLC and provided a letter relinquishing the previous issued license, as of the date of expiration. Camino confirmed the matter had been advertised as required, all fees were paid and the Liquor Division requirements had been met. She requested approval of the application, contingent on official approval by the Liquor Commission. Chairman Novotny called for public comment. Hearing none, Commissioner Perry moved to approve the license; Commissioner Shelley seconded and the motion carried. The hearing was closed at 9:34 am.

County Planner Jim Waller provided an update on the Comprehensive Land Use Plan Request for Proposal. The county received submissions from Y2 Consultants, LLC and WWC Engineering. Waller explained that both firms are qualified applicants, however, after carefully comparing the two, his recommendation is to hire Y2 Consultants, LLC to provide Johnson County with the new Comprehensive Land Use Plan. Commissioner Shelley moved to hire Y2 Consultants; Commissioner Perry seconded and the motion carried.

County Assessor Steve Esponda, County Planner Jim Waller and Commissioner Assistant Jody Telkamp provided another update on the website redesign. County Attorney Ruby confirmed that the contract had been amended to meet his previous requirements. Commissioner Shelley moved to sign the contract engaging Vestor Logic for the new website as presented. Commissioner Perry seconded and the motion carried. Ruby indicated he would contact Revize and inform them that their services would no longer be needed.

Chairman Novotny presented for approval vouchers in the amount of \$201,690.92. Commissioner Perry moved to approve the vouchers as presented; seconded by Commissioner Shelley. The motion carried.

Chairman Novotny called for any other business and for any public comment. Jim Waller presented a question to the commissioners regarding the consequences of inaction on the budget from the legislature. Chairman Novotny explained the process should that happen.

Commissioner Meeting March 19, 2024

The regular meeting of the Board of County Commissioners was brought to order by Commission Chairman William J Novotny, III at 9:00am on Tuesday March 19, 2024. Attending were Commissioners Jeff Shelley & Bob Perry, Commissioner's Assistant Jody Telkamp, Assistant County Attorney Barry Crago, and County Clerk Jackie Camino.

Commissioner Perry moved to approve the minutes for March 5; seconded by Commissioner Shelley. Motion carried.

Chairman Novotny opened the scheduled budget amendment hearing regarding Resolution #718. Clerk Camino presented the resolution for approval which would amend the FY budget for 2023-2024 by \$105,591.32. The change represents funds from the Wyoming Secretary of State of \$3,454.00 to Fund 427; funds from Rocky Mountain Power Foundation of \$2,200.00 to Fund 436, funds from the National Opioid TEVA Settlement Fund of \$3,246.43 to Fund 57; funds from the National Opioid Allergen Settlement Fund of \$3,117.88 to Fund 57; funds from the Wyoming Dept of Health of \$1,000.00 to fund 43; funds from Wyoming Office of Homeland Security in the amount of \$21,846.79; funds from Wyoming Dept of Transportation of \$70,726.22 to Fund 39. Novotny read the resolution then called for public comment. Commissioner Perry moved to approve Resolution #718, Commissioner Shelley seconded and the motion carried.

Clerk Camino presented the 2022 Emergency Management Preparedness Grant agreement in the amount of \$20,846.79 on behalf of Emergency Management Coordinator Jimmy Cataline. Camino explained that the contract between Johnson County and the Wyoming Department of Homeland Security represents the balance of funds in the 2022 grant. The grant stipulates a 50% matching requirement that doesn't expire until September 30, 2024. so we can plan for our match in the upcoming budget session. Assistant County Attorney Barry Crago confirmed he'd reviewed the contract and had no concerns. Commissioner Shelley moved to approve the amendment to the agreement; Commissioner Perry seconded and the motion passed.

County Planner Jim Waller presented the contract proposed by Y2K Consultants, LLC for the Comprehensive Land Use Plan. Waller explained that he'd sent it to Assistant County Attorney Barry Crago for review and there are some minor corrections to be made. Crago will address the items of concern with Waller and Y2K. No formal action was taken on the contract pending necessary changes. Waller also provided a brief update to the commissioners on the Planning & Zoning department.

Chairman Novotny presented a notice the county received pertaining to a special use permit at 222 Bozeman Ave, lots 5,6, and 7 for new residential construction of a duplex. Novotny explained that the county options are to send a response of approval, denial, or send no response at all. The county received the notice because of the proximity the project is to county owned property. Commissioner Shelley moved to send an approval response; Commissioner Perry seconded and the motion carried.

Chairman Novotny discussed the Johnson County Commissioner Scholarship. Since the awards were presented last year on May 17th, Chairman Novotny proposed an application deadline of April 26th, with a decision to be made at the May 7th meeting. Commissioner Perry moved to set an application deadline of April 26th with a decision date of May 7th. Commissioner Shelley seconded and the motion was approved.

Chairman Novotny announced that the City/County Cleanup event has been scheduled for May 15-18th and vouchers will be coordinated through the Treasurer's office to get them out to the public when available.

Chairman Novotny presented vouchers for approval in the amount of \$149,645.20. Commissioner Perry moved to approve the vouchers as presented; seconded by Commissioner Shelley and the motion carried.
