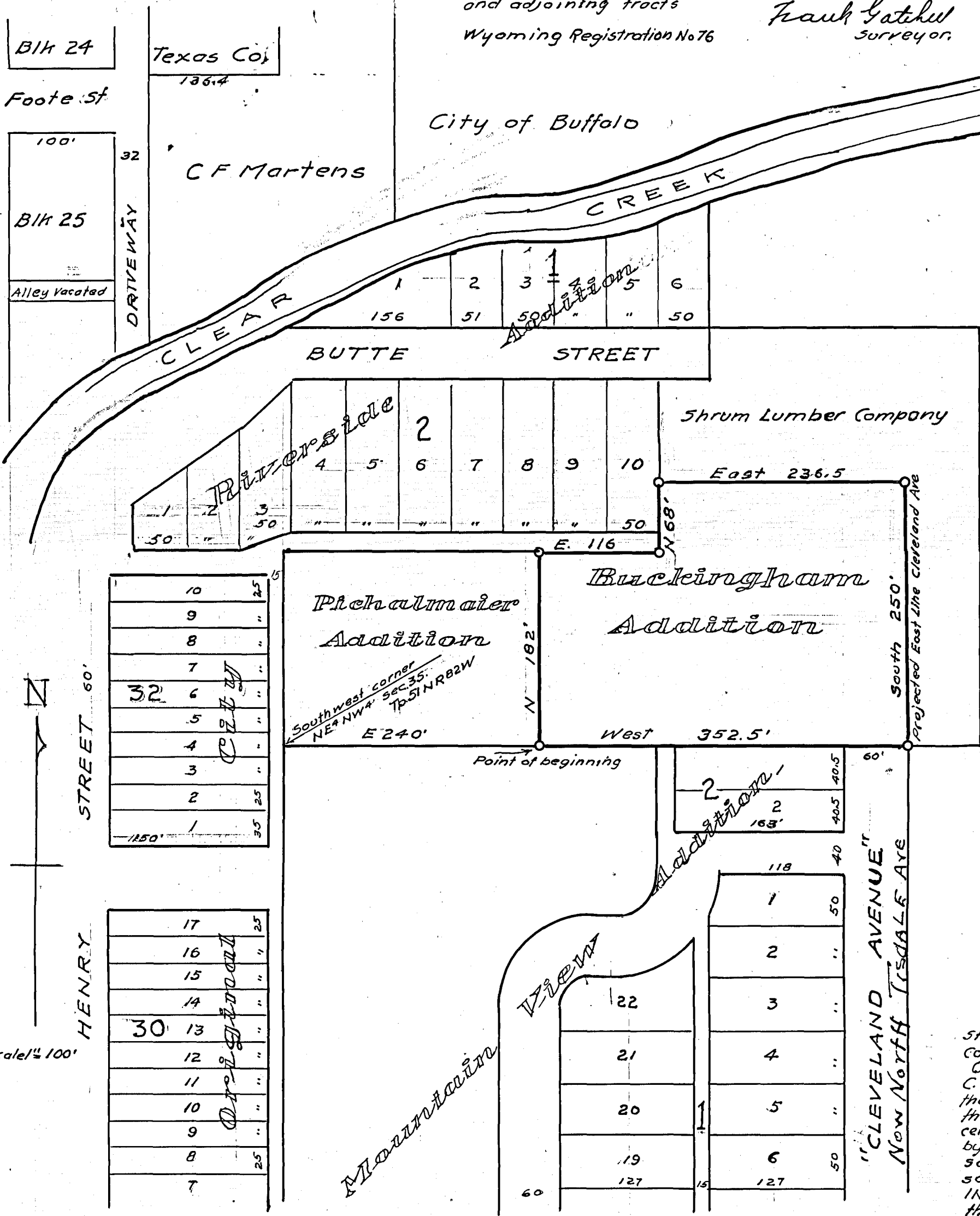

We, Porter B. Buckingham and Leta E. Buckingham the undersigned do hereby certify that we are the owners and proprietors of the foregoing Buckingham Addition or sub-division of the City of Buffalo, Wyoming and the land therein included as the same appears on this plat, that it is with our consent and in accordance with our desires that said land shall appear on said plat in said subdivision, and that the following is a correct description of the boundary lines thereof to wit; beginning at the southeast corner of Pichalmaier Addition to the City of Buffalo, which point bears easterly a distance of 240 ft. from the southeast corner of the NE¹/₄ NW¹/₄ Sec. 35, T¹/₂ S¹/₂ N¹/₂ R¹/₂ W 6th P.M. running thence northerly along the east line of the Pichalmaier Addition a distance of 182 ft.; thence easterly along the south line of the Riverside Addition to the City of Buffalo, 116 ft.; thence northerly along the east line of said Riverside Addition, 68 ft.; thence easterly and parallel with the south line of the said NE¹/₄ NW¹/₄ of Sec. 35, a distance of 236.5 ft. more or less to a line which is a projection of the east line of Cleveland Avenue, in the Mountain View Addition, City of Buffalo; thence southerly along the said projected east line of Cleveland Avenue a distance of 250 ft.; thence westerly along the south line of the said NE¹/₄ NW¹/₄ Sec. 35, a distance of 352.5 ft. to the point of beginning, containing 1.84 acres in the NE¹/₄ NW¹/₄ Sec. 35, T¹/₂ S¹/₂ N¹/₂ R¹/₂ W.
