



**DALOMAR ADDITION
TO THE

A tract of land located in Lot 4 of Section 26, T51N, R82W, of the 6th P.M., Johnson County, Wyoming, said tract being more particularly described as follows:

Commencing at the northeast corner of the Resubdivision of the Born Addition to the City of Buffalo, Wyoming as filed in the Office of the Clerk of Johnson County, Wyoming in Plat Book #2, page 105, said northeast corner being the true point of beginning;

thence N89°22'26"W along the North line of said Resubdivision of the Born Addition, a distance of 60.14 feet to a point, said point being the southeasterly most corner of the Camino Addition to the City of Buffalo, Wyoming as filed in the Office of the Clerk of Johnson County, Wyoming in Plat Book #2, page 82;

thence N00°46'53"E along the Easterly most boundary of said Camino Addition a distance of 344.97 feet to the northeast corner of said Camino Addition;

thence N00°53'52"E a distance of 634.54 feet to a point, said point lying on the North line of said Lot 4 of said Section 26;

thence N89°47'04"E along said North line of said Lot 4 of said Section 26 a distance of 59.70 feet to a point;

thence S00°49'50"W a distance of 980.39 (Record 980.42) feet to the true point of beginning.

Said tract of land containing 1.35 acres, more or less.

The undersigned proprietor of the above described tract of land has caused the same to be subdivided in the manner shown on this plat which subdivision shall be known as the "DALOMAR ADDITION".

Said plat is proposed and offered with free consent and in accordance with the desires of the undersigned owner and proprietor, and the undersigned owner and proprietor does hereby release and waive all rights, under and by virtue of the homestead and exemption laws of the State of Wyoming.
