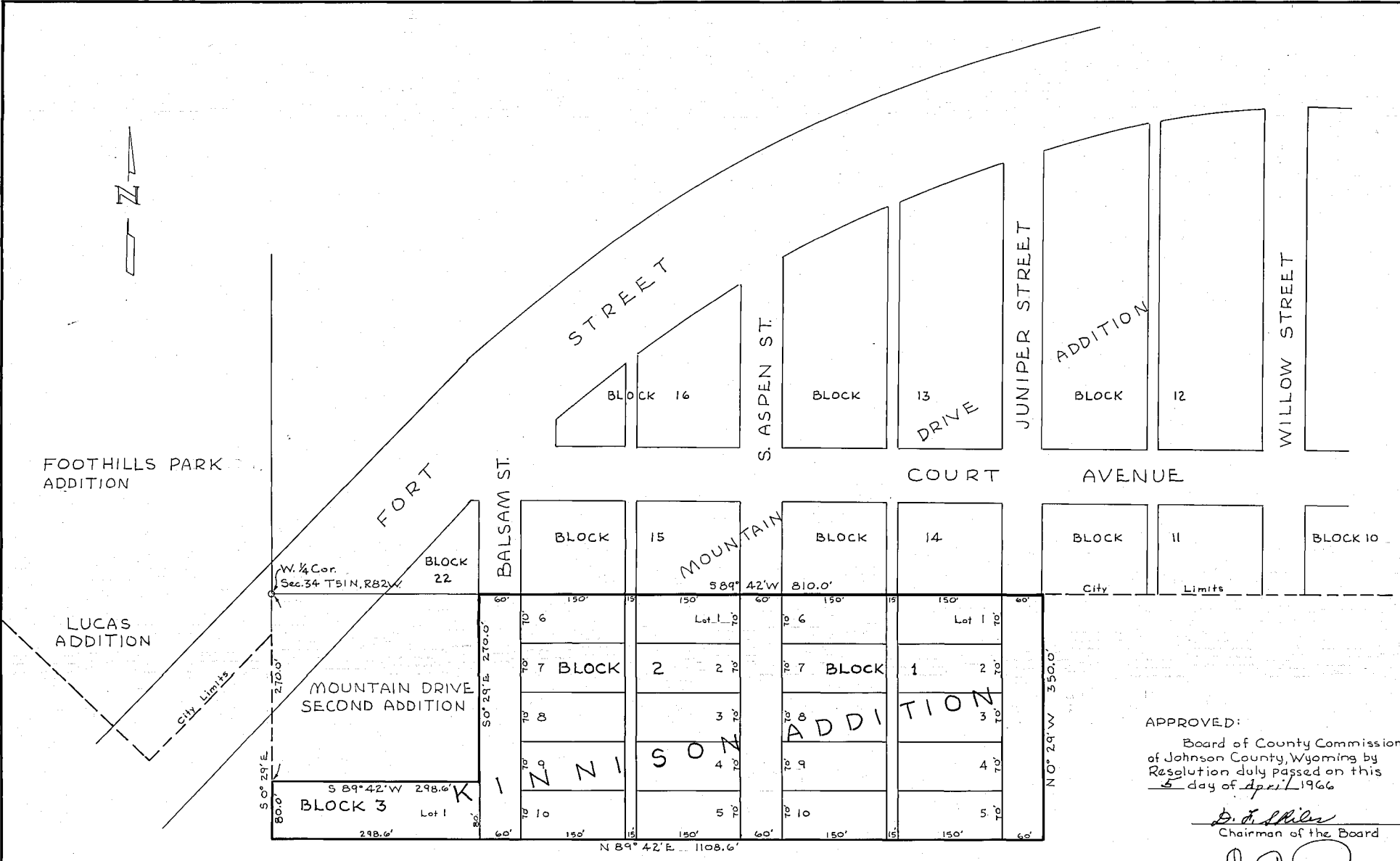

CERTIFICATE OF DEDICATION
