

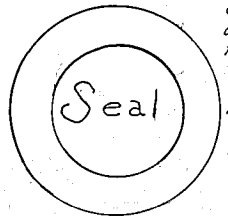
CERTIFICATE OF DEDICATION
 We, the KLONDIKE GRANGE No. 70 and the CITY OF BUFFALO, Buffalo, Wyoming, hereby certify that the KLONDIKE GRANGE ADDITION, to the City of Buffalo, as it appears on this plat is with our free consent and desire, the streets as shown are hereby dedicated to public use. The respective owners and lands are as follows:

KLONDIKE GRANGE No. 70 - Beginning at a point $S88^{\circ}54'E$ 15 feet of the northeast corner of Block 59, Burlington Addition to the City of Buffalo, thence $S1^{\circ}30'W$ 150 feet, thence $S88^{\circ}54'E$ 129.1 feet, thence $N1^{\circ}15'E$ 150 feet, thence $N88^{\circ}54'W$ 128.5 feet to the point of beginning, all in Lot 4, Section 26, T51N R82W, 6 P.M.

CITY OF BUFFALO - Beginning at a point $S88^{\circ}54'E$ 15 feet of the northeast corner of Block 59, Burlington Addition to the City of Buffalo, thence $S88^{\circ}54'E$ 128.5 feet, thence northerly along the west right-of-way line of original location of U.S. Highway No. 87 to the north line of Hogerson Street extended, thence $N88^{\circ}54'W$ 135.7 feet, thence $S1^{\circ}30'W$ 80 feet to the point of beginning, all in Lot 4, Section 26, T51N R82W.
