#### **GOVERNOR OF WYOMING**

President Trump has granted Governor Gordon's Disaster Declaration Request. The declaration will allow all 23 of Wyoming's counties and the Eastern Shoshone and Northern Arapaho Tribes to access funding and services for crucial assistance during the COVID-19 pandemic.

#### **JOHNSON COUNTY HEALTHCARE CENTER**

##### **COVID-19 Status**

- **Johnson County** has 11 confirmed cases; 2 probable cases; 1 Covid-19 related death to date. 10 of the confirmed cases have recovered.
- **Wyoming** has 275 lab-confirmed cases; 98 probable cases; and 1 Covid-19 related death.. Probable cases are identified family members of a confirmed case who exhibit symptoms but have not been tested. This figure includes 94 documented recoveries.
